ANNEXURE-II

Terms & conditions of Tender call Notice for Hiring of Vehicle in respect of ICDS Project Ranpur.

The following term & conditions must be fulfilled by the successful Bidder for providing a Vehicle on hire on monthly rent basis as laid down in FDMO No. 34085/ F Dt. 29.09.2012 read with MO No. 27037/F Dt. 08.10.2015.

- 1 - The Vehicle must be in Road Worthy condition, shall not be more than 03 years old from the date of initial registration and must have valid registration certificate, Insurance Certificate proof of up to date tax payment etc. which are mandatory for plying of vehicle.
- 2 - The Hired Vehicles during period of contract shall have all necessary valid MV documents such as : Valid Registration Certificate, Insurance Certificate, Fitness Certificate, proof of up to date tax payment etc and D.L of the driver available all the times. The Deptt. / office hiring the vehicle shall not be responsible for any damage/ loss caused to hired vehicles or loss of life / injury made to any person or damage to any property on account of use of hire vehicle any manner whatsoever. The hirer shall be responsible for all such litigation.
- 3 - The Vehicle must achieve a fuel efficiency of 15 kms per litre for AC Indigo/44 kms for AC swift Desire petrol & 17 km for AC swift Desire (Diesel).
- 4 - The details of the make and year of manufacture of the vehicle, registration No. Mileage (Kms covered per litre) and name of the Driver with Driving License No. and period of validity should be specifically provided in the general bid information to be furnished with the Quotation /Tender (Annexure-III).
- 5 - The hirer charges to be paid for monthly basis is final but does not include cost of diesel which is to be paid separately basing on actual consumption & lubricants as per existing Govt. Norms. All the expenditure of the vehicle towards repair , replacement of spare parts, lubricating oil of Engine, Gear Box & differential Coolant, Tyres & Tubes Battery etc. will be borne by the Bidder.
- 6 - Monthly hire charges & reimbursement towards cost of diesel (as per actual) and Lubricants (as per Govt. Norms) of selected bidder will be paid in every succeeding month, as per as possible within 15 days of the submission of bills by the service provider & no advance payment will be made.

7 - A sum of Rs. 5000/- shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the CDPO Ranpur and submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.

8 - The application form of Tender containing General Bid Information & Terms and conditions for hiring of Vehicles etc. will be available in the office of the ICDS Project Ranpur on payment of Rs. 100/- from 11.07.2019 to 30.07.2019 or can be downloaded from Dist website, www.nayagarh.nic.in. The applicant shall furnish Demand draft for an amount Rs. 100/- (Rupees one hundred) only towards the cost of application form along with the application in case the application form is downloaded from Dist web site.

9 - The monthly rate of hire charge be quoted separately in the general bid information (excluding fuel and lubricants) & should not exceed the monthly ceiling price of **Rs. 16000/-** per month.

10 -The lowest rate offered by the bidder shall be accepted & approved by the Collector Nayagarh.

11 - After Completion of Tender process, an agreement will be executed with the lowest bidder as per the terms & conditions laid down in FDMO No. 34085/ F Dt. 29.09.2012 read with MO No. 27037/F Dt. 08.10.2015 before use of the hire vehicle.

12 - In case of break down for reasons whatsoever the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle / bidder.

13 - It shall be the responsibility of the Bidder to provide a good driver & the salary of the driver shall be borne by the owner.

14- The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.

15 - The Driver should be well behaved, gentle and obedient in nature.

16 - The Vehicles shall report for duty for minimum of 26 days in a month

17 -In case of emergency the driver will have to report for duty as per the requirement of hirer. No extra payment shall be demanded.

18- The Mobile number of the driver so engaged by the successful bidder should be available & open all times. So that , he can be informed for duty during emergency times as & when required by the authority including Govt. Holidays being nominated as child marriage prohibition officer by Govt. In WCD Deptt Odisha Bhubaneswar
