



Interested Registered Outsourcing Agencies/ Service Providers of Nayagarh District Jurisdiction having GST clearance are invited to quote their rate of service charges for providing manpower for temporary engagement of candidates as Peon/Chowkidar/Driver in ARD Sector of Nayagarh District. The Firm should have providing E.P.F/E.S.I.C. facility to the beneficiaries engaged for the purpose. The persons to be engaged should have following eligibility.

1. Should be Indian & permanent resident of Nayagarh District.
2. Qualification: - Passed M.E., able to speak, read & write Odia language.
3. Should have good character.
4. Should have one spouse in case of married.
5. Age:-Should not be less than 18yrs. on 01.01.2019 & more than 32yrs.  
5yrs relaxation may be allowed in case of SC/ST/SEBC category.  
In case of interested working Gomitra of the district, the upper age may not be more than 45yrs.
6. Physical Standard:-a) Should not have any physical defect.  
b) Should have good physique with minimum height of 5'(Five Feet) & unexpanded chest of 30''(Thirty Inches).  
c)Should know good cycling.  
d) In case of Driver, he should have a valid Driving License of LMV type.

The candidates will be engaged at different Veterinary Institutions of the Dist. The Firm is to make payment to beneficiary regularly. The payment of remuneration of the beneficiary will be paid on availability of Funds/ Allotment and as per rule prescribed by the Govt. of Odisha from time to time. The Firm is to bear any loss/damage caused/done/made by the candidate. The services of candidates/beneficiary will be terminated at any time without assigning any reason thereof. The candidate should have good behavior, active habit & obedient. The service will be terminated on notice of any irregularities misbehavior/disobedience to the order of higher officers under whom works assigned.



The quotations will be opened on **Dt: 07-08-2019** at 11.00AM in presence of committee members for finalization of rate of service charges.


