Eligibility Conditions :-

- (1) Officers who have retired from Government service on attaining the age of superannuation and below the age of sixty five years having good service records and are physically fit shall be eligible to be considered for re- employment.
- (2) Officers against whom departmental proceedings or criminal cases are contemplated/pending or who have been penalized for misconduct during the period of preceding five years will not be eligible for consideration.

On engagement, the retired Government servant will avail remuneration only in consolidated manner as per prescribed remuneration structure attached to the Level in the Pay Matrix as given below as per Finance Department Memorandum No-7022 dt-17-03.2018.

Terms and Conditions:-

(1) Re-employed officers shall be governed by the provisions of Odisha Govt. Servants Conduct Rules, 1957 and shall be liable to be proceeded against for their misconduct, omission and commissions as per the provisions under the Odisha Pension Rules, 1992.

(2) The re-employment can be terminated at any time by the respective appointing authority due to unsatisfactory performance of any of the re-employed officer by giving one month notice. On the contrary if any re-employed officer desires to resign he shall do by giving one month's written notice to the competent authority.
