Application invited for Contractual Engagement for Gram Rozgar Sevak (GRS)

Applications are invited for filling up Gram Rozgar Sevak (GRS) under MGNREGA for Nayagarh District on contractual basis with consolidated monthly remuneration of Rs. 7,000/-PM (Rupees seven thousand)only which may be revised with approval of Government.

Domicile:

The intending candidates should be a resident of Nayagarh District.

Reservation:

Post Based Reservation Policy is being adopted at present in place of vacancy based 80 Points Model Roster which is no more in operation as per the guidelines of Govt. in PR & DW, Deptt. vide letter No. 19697 dt. 01.11.2019

Age :

A candidate must have attained the age of 18 years and must not be above the age of 40 years as on 01.12.2019. Age should be determined as per the matriculation/HSC Certificate of the candidates.

Examination Fees :

A candidate is required to pay non-refundable and non-adjustable fee of Rs. 50/- as examination fee for Computer Test in favour of Project Director, DRDA, Nayagarh in shape of DD payable at Nayagarh. Other mode of payment shall not be accepted. Candidates belonging to Schedule Caste and Schedule Tribe are exempted for payment of examination fee.

How to Apply :

- Candidates must go through the details of the advertisement available in the District website i.e. www.nayagarh.nic.in.
- The candidates should send their application through Registered Post/Speed Post only to the Project Director DRDA, Nayagarh, At/Po/Dist- Nayagarh, Pin- 752070 by super scribing on the envelope as "APPLICATION FOR THE POST OF GRS" within the deadline along with all required documents as per the advertisement uploaded in the website. The candidates are advised to go through the terms and conditions, security, verification & engagement details before applying for the position.

Terms& Conditions :

- Applications received incomplete, in any other format or by any other means shall be out-rightly rejected.
- All posts are contractual in nature and engagement is initially for a period of one year which can be extended depending upon the requirement and satisfactory performance.
- The selection of candidates shall be strictly on the basis of marks obtained in 10+2. Mark Secured in the 4th optional shall not be included. In case, two or more candidates secure the same marks in the examination, the candidate older in age as per Date of Birth in the HSC certificate (within the stipulated age limit) will be placed above the younger. Further, if the age of two or more candidates is same, the candidate who has passed HSC examination earlier will be placed above the other in the select list.
- The candidates will be engaged in any Gram Panchayat of the District by the Collector-cum-CEO, Zilla Parishad , Nayagarh.
- An undertaking should be submitted by the selected GRS as per the prescribed format given by PR & DW Department vide letter No6681 Dt. 06.04.18.
- The select GRS will execute an engagement with Collector-cum-CEO, Zilla Parishad, Nayagarh in non-Judicial stamp paper and the Collector-cum-CEO, Zilla Parishad, Nayagarh issue engagement order after execution of agreement.



- Collector-cum-CEO, Zilla Parishad, Nayagarh is the disciplinary authority of the GRS and is competent to terminate the contract and disengage the GRS on the grounds of violating the terms & conditions of engagement.
- If any fraudulent testimonial is detected in future if any he/she shall be criminally prosecuted, the engagement shall be cancelled without notice and action as deemed proper & fit will be taken against him/her as per the provision of law.
- The post of GRS is transferable in nature within the District. The Collector-cum-CEO, Zilla Parishad, Nayagarh is the competent authority to transfer the GRS from one Gram Panchayat to another Panchayat within the District in view of exigency of public service or in consideration of genuine grievance or on administrative grounds.

- The last date of filling objection to be clarified will be given at the time of publication of scrutiny list of candidates.
- The list of provisionally selected candidates & final merit list will be published in the district website www.nayagarh.nic.in
- The Collector-cum-CEO, Zilla Parishad, Nayagarh reserves all rights to reject or accept any or all application(s) without assigning any reasons thereof.
- Authority shall not be responsible for any postal delay.


