



TERMS AND CONDITIONS OF TENDER FOR APPOINTMENT OF TRANSPORT AGENT UNDER S.N.P FEEDING PROGRAMME FOR LIFTING & TRANSPORTATION OF RICE & WHEAT FROM FCI POINT TO AWCs/WSHG's POINT IN NAYAGARH DISTRICT FOR THE YEAR 2018-19.

1. The tender paper should be filled up properly and legibly without any correction/overwriting. The rate and unit should be written both in words and figures in the tender. The rate quoted should be final and the tenderer shall not be allowed to change the same under any circumstances and it should be valid for one year.
2. Certificate from District Collector/any Govt. /semi Govt. organization etc. about past experience and performance if any in handling storage/transport work will be furnished along with the tender paper. Accepting authority shall have the right not to accept tender(s) of registered transport Contractors/Agents/Individuals who have not performed satisfactorily in the preceding years under Govt. of Odisha.
3. Earnest money of Rs.10,000/- (Rupees Ten thousand) only in shape of Postal Savings pass book/Bank pass book/N.S.C/ Term Deposit duly pledged in favour of Collector, Nayagarh shall be furnished along with the tender. The E.M.D amount shall be refunded to the unsuccessful tenderers after finalisation of tender process. The Earnest money deposit by successful tenderers will be converted in to security deposit which will be refunded after successful completion of the period of contract and audit of accounts.

No tenderer shall be allowed to withdraw his tender/earnest money deposit until the tender is finalized. In case the successful tenderer refuses to undertake the transporting assignment after acceptance of his tender, earnest money deposited by him will be liable for forfeiture. The whole or part of the security deposit will be forfeited for irregular performance or breach of any terms and conditions of Agreement during the period of contract.

4. The successful tenderer will be required to furnish a security deposit of Rs. 1,00,000/- (Rupees One lakh) only in shape of Postal savings pass book/Bank pass book/N.S.C/ Term deposit duly pledged in favour of Collector, Nayagarh for the period of contract from the date of signing the Agreement, which will be refunded after successful completion of the period of contract and audit of accounts.
5. Up to date VAT clearance certificate shall be furnished along with the tender.
6. Valid Agent's Licence registered for common carriers under Road Carriages Act.2007 from the competent authority shall be furnished along with the tender.
7. The agent will be responsible for delivery of the stock at AWC Point on proper weighment. 20% weighment test check will be made by the stock receiving officer and expenditure incurred to that effect will be borne by the Transporting Agent.

8. The detailed tender paper should be returned with the tender duly signed by the tenderer as a token of acceptance of terms and conditions.
9. List of trucks owned by the tenderer with up to date documents (Xerox copies duly attested) shall be furnished along with tender.
10. Payment shall be made against submission of bills on completion of delivery of stock as per order of the competent authority on production of printed serially numbered delivery challans duly acknowledged by the recipient of stock to whom it is concerned as per the approved rates incorporated in the agreement. The D.S.W.O, Nayagarh shall have the right to deduct and adjust any amount found recoverable towards loss and damage or both. No advance payment will be made. The transportation cost will be paid subject to availability of funds.
11. The successful tenderer shall have to execute an agreement with the Collector, Nayagarh as per terms and conditions as specified in the agreement form at his own cost within 7 days of the intimation of acceptance of his tender.
12. The authority may terminate the contract for violation of terms of agreement or any other reason to be recorded in writing.
13. In case of violation of conditions of tender the Transporting Agent will be booked under I.P.C, Essential Commodities Act, Prevention of Food Adulteration Act, and Prevention of Black Marketing Act.
14. Registered transport Contractors/Agents/Individuals having adverse record will not be entertained.
15. The tender paper along with the papers of earnest money deposit and other required documents in a sealed cover should reach the District Social Welfare Officer, Nayagarh through registered post/speed post by 3.1.2020 up to 5.00 P.M. The sealed tender envelope should be superscribed as "SEALED TENDER FOR APPOINTMENT OF TRANSPORTING AGENT UNDER S.N.P FEEDING PROGRAMME FOR RICE & WHEAT OF NAYAGARH DISTRICT DURING THE YEAR 2018-19"

The sealed tender will be opened by the undersigned in presence of the tender committee and the tenderer or his/ her authorized Agent on 04.01.2020 at 11 A.M/P.M in the office of the undersigned. The tender without earnest money deposit and other required documents shall be liable for rejection.

16. The successful tenderers will lift the rice from PEG Depots, Kanakata and wheat from F.C.I. Godown and make delivery of the same at all the AWC points & PIR SHG points of the Dist. as per instruction of the Collector/D.S.W.O from time to time. Q.2200.00 of Rice and Q.4400.00 of Wheat per quarter are to be transported from the nearest FCI Godown to all the AWC points of this District under SNP feeding programme during 2019-20.
17. The tender received beyond the stipulated date and time shall be liable for rejection.
18. The undersigned reserves the right to accept or reject any or all the tenders without assigning any reason there of.

NATURE OF WORK AND PAYMENT

1. The work is to be carried on with due diligence and in accordance with the instructions to be issued from time to time by the Women & Child Development Department, Odisha /Collector, Nayagarh/DSWO, Nayagarh.

The bills will be submitted at least once in a month to the DSWO on completion of delivery of stock as per orders of the competent authority on production of printed serially numbered delivery challans duly acknowledged by the recipients of stock to whom it is concerned with other documents for payment of dues. Soon after receipt of funds from Govt. the payment will be made. The DSWO shall have the right to deduct and adjust any amount recoverable towards loss and damage or both of the foodstuff.
3. The Collector may terminate the contract for violation of terms of agreement.
4. Payment shall be made as per approved rate incorporated in the agreement.
5. No request for enhancement of approved rate shall be entertained during the terms of Agreement.
