Stated quotation/tender are invited from interested reputed Travel Agencies/Tour or private individuals for providing one no. of non-AC diesel driven vehicle, i.e: Bulero/Marshall/Tata Sumo/Mahindra Max/Indigo & Indica eV2 having sitting capacity not more than ten including driver, which shall confirm to the terms and conditions (Annexure-II) for official use in **ICDS Project, Gania** Department/Office on monthly rent basis.

1. The vehicle must be in road worthy condition and must have valid Registration Certificate, Insurance certificate, fitness certificate, valid contract carriage permit, proof up to date tax payment etc. which are mandatory plying of vehicle.
2. The driver of the vehicle must have a valid driving license for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
3. The driver should well behaved, gentle and obedient in nature.
4. A sum of Rs.5000/- (Rupees Five Thousand) only shall be deposited by intending bidders in shape of Account Payee Bank Draft drawn in favour of the **CDPO, Gania** and submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
5. The monthly rate of hire charge be quoted separately in general bid information (Excluding fuel cost)
6. The vehicle must achieve a fuel efficiently of **15 Kms per liter** for Indigo/**17 km per liter** for IndicaeV2 & **10 km per liter** for Bulero /Marshall/Tata Sumo & Mahindra Max respectively.
7. The upper ceiling limit for monthly hiring charges excluding POL is fixed at **Rs.15,000/-** (Rupees Fifteen thousand) only.
8. The details of the make and year manufacture of the vehicle, registration No., mileage (Kms. covered per liter) and name of the driver with driving license No. and period of validity should be specially provided in general bid information to be furnished with the Quotation/Tender (Annexure-III)

Website www.odisha.gov.in from Dt. 26.02.2020 to 18.03.2020. The applicant shall furnish in shape of cash for an amount Rs.100/- (One hundred) only towards the cost of application along with the application.
