

She/he must have valid registration from the Odisha Council of Medical Registration. Age:- upto 70 years as on dt.1.3.2020. |
| 2 | MO MBBS-(SNCU,NPC DCS,DEIC) | MBBS degree from an institution recognised by Medical Council of India . She/he must have completed compulsory internship & must have valid registration from the Odisha Council of Medical Registration. Age:- upto 70 years as on dt.1.3.2020. |


General Terms & Conditions:
