Background of the Project:

As per the demography of Nayagarh district, one fourth of total agricultural laborers are female. Main occupation of this district is agriculture and allied activities. The data of workers in household industries are also not encouraging. Hence, without supporting additional income activities to women we cannot even imagine of women empowerment which is a prime concern of Government.

Aim & Objective of the Project:

The main aim of this program is to enhance the quality of life of women through increased knowledge and skills. We have realized that merely imparting literacy would not be sufficient (the literacy rate of Nayagarh district is 80%). The women need vocational training or skills also to uplift their status. They should be able to stand on their feet and be an earning member of the family. By considering the ample strength, addressing the weakness and grabbing the opportunities, this project aims to creating self-employment opportunities for the disadvantage section of the society especially women in specific at their neighborhoods through formation of Producer groups and establishing production unit for production quality apparel making.

Promoting income generation activities is a priority for the state government. Garments manufacturing has been identified as an activity which can be taken up especially by the women of rural areas. These women are hard working and have a good aptitude for stitching and other allied activities related to garment manufacturing. The District administration, Nayagarh is looking for an anchor entrepreneur/ enterprise that can provide the required expertise on school uniform stitching in Nayagarh district.

District administration, Nayagarh invites Expression of Interest (EOI) from reputed organizations/individuals in India desirous of setting up of stitching Unit of school uniform at ITI, Khuntubandha, Nayagarh. The

anchor unit will provide raw materials; machines and training to the women in the centers where trainees will be trained to stitch school uniforms.

The eligible organizations may submit their responses in sealed envelopes to the Dy. CEO, ORMAS, Nayagarh, Odisha within 07 days from the date of publication of the advertisement in the newspaper/ print media.

Scope of Work

The proposed approach in this respect is as under:

1. The interested entity shall submit a concept paper containing sufficient detail of the proposed methodology to be adopted for operation of the said tailoring centre at ITI, Khuntubandha, Nayagarh, Odisha.
2. The District Administration, Nayagarh shall be responsible for providing necessary infrastructure in terms of land and building, machinery and other accessories for training (raw material and logistic support).
3. The interested entity shall be responsible for providing experienced trainer, rent of building and electricity/ water cost.
4. The interested entity shall be responsible for mobilizing the necessary human resource for setting up of the centre.
5. Each batch will be of 40 to 45 trainees for one month. Training of each batch will be of **minimum 240 hrs (only practical)**.
6. Training will for residential course only.
7. The PIA will have to pay security deposit of **Rs. 25,000.00** (Rupees twenty five thousand) only through NEFT/RTGS to the bank A/c as detail given below –
