The tender paper should reach in the office of the undersigned on or before 19.02.2021 by 5.00PM. The tender paper should be submitted by Regd. Post / Speed Post only. The tender paper will be opened by the DSWO, Nayagarh in the office chamber of DSWO, Nayagarh on 22.02.2021 at 4.00 PM . The sealed tender covers containing the tender paper should be super scribed as "Tender paper for purchase of Govt. vehicle condemned".

The upset price of the condemned vehicle is fixed to Rs. 23500/- (Rupees Twenty Three Thousand Five Hundred) only. The vehicle can be inspected during office hours of any working day from 10.00 AM to 5.00 PM in the garage of CDPO, Nayagarh.

Intending tenderers are required to enclose a demand draft of Rs. 5000/- (Rupees Five Thousand) only in favour of CDPO, Nayagarh payable at State Bank of India, Nayagarh Main Branch as earnest money failing which the tender will not be accepted. The earnest money shall be refunded to the unsuccessful tenderers after finalization of the tender. The tenderers or their authorized representatives should be present at the time of opening of the tender papers. The highest price offered by the tenderer should be submitted through financial bid in prescribed format (enclosed).

The highest tenderer, whose tender would be accepted, shall deposit 25% of the offered amount immediately after the same confirmed and balance amount must be deposited within 7 days through Bank draft in favour of CDPO, Nayagarh payable at State Bank of India, Nayagarh Main Branch from the date of opening of the tender paper failing which the deposited amount along with the earnest money shall be forfeited. After completion of tender process along with all financial clearance by the accepted tenderer, an affidavit to be executed before the Executive Magistrate for sale of the condemned vehicle.
