The Common Mark List, Category wise provisional selected list along with waiting list of candidates who appeared the entrance test on 01st March, 2020 in Nayagarh District for admission into Class-VI in OAV Dwaragaon, Daspalla, OAV Balarampur, Ranpur & OAV Fategarh, Bhapur for 2020-21 is hereby published in the notice board of concerned BEO –Cum- Principals/ Block Education Offices, District Education Office, Nayagarh & Office of Collector & District Magistrate, Nayagarh, The candidates selected in the entrance examination for Class-VI in 2020-21 shall continue their education in Class-VII in 2021-22 on the result of selection process as per decision of Govt. and the vacant seats will be filled up from the waiting list of last year approved list in Class-VII in 2021-22. The date of admission from provisional selection list and admission of lateral entry students will be started from 06.04.2021 to 20.04.2021 whereas the admission from the waiting list shall be commenced from 21.04.2021 to 25.04.2021 (Time: 7.00.a.m. to 11.00.a.m.) on all working days. The candidates shall report before the OAV, Principal/BEO-cum Principal (I/C) concerned of their block for their admission with the following documents in original along with photocopy for verification as per the dateline indicated above.

1. Original TC/SLC issued by the Head of the Institution (Duly countersigned by the BEO/DEO in case of the candidate belong to other block & district).
2. Caste certificate from the competent authority in case of SC/ST category candidates.
3. Certificate from the employer in case of candidates selected under State Govt. Services or State PSUs.
4. P.H certificate from the competent authority in case of PH category.
5. Two recent Passport size photographs of the candidates.
6. Residential certificate from the competent authority or the concerned Sarapanch/ Councilor/ Corporator.
7. Aadhar Card.
8. Bank Passbook.

The claim for seat of admission will be rejected in case the candidates fails to produce the original documents during the time of admission or any information furnished in the application by the candidate is found to be false, forged, fabricated or fails to take admission within the scheduled time. The Principal/BEO-cum-Principal (I/C) of OAV concerned shall take steps to admit the selected students duly verifying the documents/certificates of the selected candidates and maintain "Admission and Withdrawal Register" for the OAV. The SOP/safety Guidelines of COVID-19 issued by School & Mass Education Department, Govt. of Odisha must be strictly followed during the process of admission to avoid spreading of Corona virus.




