Expression of interest for District Ombudsperson under MGNREGS

Applications are invited in the prescribed format from the intending persons for engagement as Ombudsperson in Nayagarh District for redressal of grievance and disposal of complaints relating to implementation of the MGNREG Act for a tenure of 2 years extendable by one year based on performance appraisal or till attaining the age of 68 years whichever is earlier .On unsatisfactory performance the Ombudsperson will be removed from the engagement. The Ombudsperson will get compensation @Rs.1000/- per sitting with maximum upper limit of Rs 20,000/-(Twenty Thousand) only per month. Sitting means per day functioning, irrespective of number of cases handled and its duration in terms of working hours. 
Eligibility Criteria:

Following are essential qualification to be an Ombudsperson.

- I. Minimum 10 years of experience in academics (teaching) or civil service or civil society organization.
- II. Person with eminent standing and impeccable integrity.
- III. Not a member of recognized political party, currently banned organization & each person shall be required to file a declaration to this effect along with the application.
- IV. Physically active, capable of and willing to conduct field visits to remote rural areas in the District.
- V. Below 66 years of age at the time of appointment.
- VI. Those who have completed at least 1 year as MGNREGA Ombudsperson will be given preference.
- VI. The Ombudsperson will have a tenure of 02 (two) years extendable not more than twice by one year each based on a performance appraisal process or till the incumbent attains the age of 68 (Sixty eight) years, whichever is earlier. There will be no reappointment.
- VIII. Must be a resident of Nayagarh District or neighboring District.

The last date of receipt of application is Dt. 16.04.2021 by 1.00 P.M and the application fulfilling the eligibility criteria should be applied in the prescribed proforma along with the copy of the required documents to **the Collector-cum-DPC MGNREGA Nayagarh, O/O Project Director, District Rural Development Agency, Nayagarh, At/Po Nabaghanapur, Odisha, Pin-752070** by the date fixed through registered post/ speed post/ courier service only. The application received after the due date shall not be considered.
