In pursuance of Notification No.-493/OSSSC dated 07/05/2021, the following candidates mentioned as under hereby provisionally appointed as Govt.contractual Nursing Officers with consolidated remuneration@ Rs.10, 000/- per month.

The above appointment is purely provisional and subject to validation of bio-data after verification of original valid documents by the undersigned and final approval of OSSSC.

Terms and conditions

1. This engagement will continue to remain provisional till acceptance of the candidature and issue of clearance by the OSSSC. Those who fail to submit the required documents to the satisfaction of the Authorities/Commission, this provisional engagement shall be terminated forthwith.
2. The inter-se seniority of the candidate shall be in the order in which their names appear in the selected list prepared by OSSSC irrespective of their date of joining.
3. The candidate shall submit his/her joining report along with scanned self-attested copies of original documents (HSC Board Certificate /+2 Certificate/GNM/B.Sc. pass out Certificate/Caste Certificate/Valid Residence Certificate/Proof of Identity Proof of working in the Covid Facility/ Self-declaration in support of working) as well as Undertaking in the format Annexed, to the concerned Appointing Authorities via email by 1st June 2021.
4. The candidate who is not presently working at any Covid facility (Government or Private) are to physically appear before the concerned CDM&PHOs with their original documents by 19th June, 2021 for physical verification of the same. For mobility during the lockdown, they can use their provisional appointment order as pass.
5. The candidates who are presently working in any Covid Facilities shall continue to work in those Facilities so as not to cause any dislocation in COVID management. These candidates shall submit a certificate of employment from the Covid Facilities where they are working/self-declaration in support of working along with other documents. They are to physically appear before their concerned Appointing Authority with original documents by a date which will be subsequently notified.
6. The candidates who are working in Private Hospitals shall join after the present Pandemic situation comes down and will physically appear before the Appointing Authorities for verification of documents. Provision of extension of joining time shall be allowed to them.
7. After issuance of the final appointment order and subsequent joining the candidate shall be eligible to get the actual scale of pay as notified by Government for Contractual Govt.employee. Till then the Nursing Officers who are working in the Govt./Private Covid facilities will continue to get the salary/remuneration from the Authorities of the respective Covid Facilities.
8. Other Terms & conditions of service will be as per the service Conditions as laid down in G.A Deptt. Notification No.32010-GAD-SC-Rules-009-2013/Gen dated 18.11.2013 for Contractual Group-C employees (Contractual Appointment.)
