The above said calendar is prepared as per the MGNREGS Audit of Scheme Rules, 2011 and Auditing Standard for Social Audit, 2016 issued by MoRD, Govt. of India. The Social Audit Team may kindly be instructed to conduct the Social Audit in strict adherence to the Covid-19 guidelines of State and Central Government.

It is therefore, instructed to all implementing agencies under MGNREGS & NFSA schemes to take suitable action for conduct of the Social Audit in the respective Gram Panchayats as per approved calendar and follow the instruction mention below.

- Publish the Social Audit Calendar in two largest circulated Odia Daily Newspapers for wide publicity.
- Instruct the field functionaries to provide all type of Case Records/Registers/ files /Guard Files/ All Documents/ Registers of NFSA etc. to Social Audit Team (DSA/BSAs/VRPs) with proper acknowledgement before 15 days of Social Audit.
- Provide accommodation to Block Social Auditors at Block during Social Audit period.
- Provide computers/Printers/Papers for printing of Social Audit Format and Uploading of Social Audit Reports.
- Ensure wide publicity of Social Audit Gram Sabha date by beating of Drums.
- Provide necessary support of minimum infrastructure like Banner, Tent, Sound System, Drinking Water and Logistics arrangements for organizing Social Audit Gram Sabha at each Gram Panchayat.
- Further, it is also requested to provide police protection, if warranted to ensure security during Social Audit process.

You are therefore instructed to follow up provisions as per the act and instructions meticulously during conduct of Social Audit Gram Sabha, Negligence in any points may instigate suitable action as deemed proper & fit.
