Order No. 2162 Dated 20.12.2021

On recommendation of the Odisha Sub-ordinate staff selection Commission, Bhubaneswar vide their letter No-1246(c)OSSSC Dt-10.12.2021 and letter No-1262 (C)/OSSSC dt-10.12.2021 and after due verification & validation of the biodata of the selected candidates held on 15.12.2021, the following successful candidates are hereby appointed as Revenue Inspectors on contractual basis with consolidated remuneration of Rs.25300/- Per Month as per the terms and conditions laid down in General Administration Department Notification No-32010-GAD-SC-RULES-0009-2013/Gen dt.12.11.2013 which will be given effect from the date of their joining to the post subject to the following terms and conditions.

1. On their appointment, they are posted to the Tahasils as mentioned against their name and they shall submit their joining report to the concerned Tahasildars within 15 days from the date of receipt of this order & they should submit the following documents at the time of their joining before the concerned Tahasildars.
 - a) Self attested Xerox copy of all qualification certificates.
 - b) Two character certificates from the Gazetted Group-A or Group-B Officers.
 - c) Medical Certificate of fitness from a Medical Officer not below the rank of an Asst. Surgeon of any Govt. Hospital.
 - d) An oath of allegiance to the Constitution of India.
 - e) Certificate of Marital Status.
2. The appointment shall continue on contractual basis as initial appointee for a period of 06 years. The period of six years shall be counted from the date of their contractual appointment under rule-5.
3. During the period of contractual appointment they shall draw consolidated monthly remuneration as per G.A.& P.G Department Notification No-28626/Gen dt-27.10.2021. Their consolidated remuneration shall be enhanced as per the said Govt. order on completion of each year of service subject to satisfactory performance.
4. They shall not be entitled to draw the DA, HRA and other allowances during the period of Contractual appointment.
5. They shall be entitled to avail leave under provision of the Odisha Leave Rules, 1966 at par with the regular employees of Govt. of Odisha.
6. They shall abide by O.C.S Conduct Rules, 1959 and O.C.S (C.C.A) Rules, 1962.
7. They shall be enrolled under the NPS contained in the OCS(Pension)Rules,2005 and OCS(Pension)Amendment Rules-2021 from the date of their contractual appointment.
8. They shall be deemed to have been regularly appointed on the date of satisfactory completion of six years of contractual services and on regular appointment they shall be entitled to draw the time scale of pay with D.A and other allowances as admissible in the corresponding Pay Matrix under O.R.S.P Rules,2017.
9. As per Finance Department Resolution No-28557 dt-08.10.2021 the benefit of G.I.S is applicable to them.
10. No Travelling Allowance is allowed for joining in the post.

11. Any document produced found to be contradictory or forged on verification at any time, their services will be terminated followed by initiation of prosecution.

12. The appointment is purely temporary and can be terminated at any time without assigning any reason thereof.
