In inviting a reference to the letters & Subject cited above, I am to intimate that, it has been decided to conduct Social Audit of PMAY-G Scheme since the FY-2016-17 to 2020-21 for five year instead of 3years and MGNREGS decided earlier. The Social Audit Team may kindly be instructed to conduct the Social Audit in the block as per the scheduled and report to the concerned authorities in a time-bound manner.


It is, therefore, instructed to all implementing agencies of MGNREGS, & PMAY-G schemes to take suitable action for conduct of the Social Audit in the respective Gram Panchayats as per approved calendar and follow the instruction mention below.

- Publish the Social Audit Calendar in the two largest circulated Odia Daily Newspapers for wide publicity.
- Instruct the field functionaries to provide all types of Case Records/Registers/ files /Guard Files/ All Documents/ Registers and all types of bills and vouchers/SECC List/System Generate Priority List/Gram Sabha and Gram Panchayat Resolutions/PWL/Year wise beneficiary list/MB/Grievance Register/Account Statement and other related document to Social Audit Team (DSA/BSAs/VRPs) with proper acknowledgment before 15 days of Social Audit.
- Provide accommodation to Block Social Auditors at Block during the Social Audit period.
- Provide Computers/Printers/Papers for the printing of Social Audit Format and Uploading of Social Audit Reports.
- Ensure wide publicity of Social Audit Gram Sabha date by beating Drums.
- Provide necessary support of minimum infrastructure like Banner, Tent, Sound System, Drinking Water, and Logistics arrangements for organizing Social Audit Gram Sabha at each Gram Panchayat.
- Further, it is also requested to provide police protection, if warranted to ensure security during the Social Audit process.

You are therefore instructed to follow up provisions as per the act and instructions meticulously during the conduct of Social Audit Gram Sabha; Negligence at any points may instigate suitable action as deemed proper & fit.

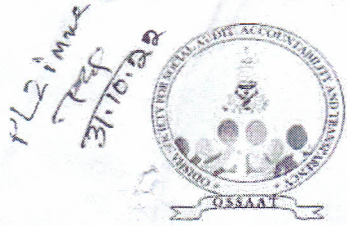

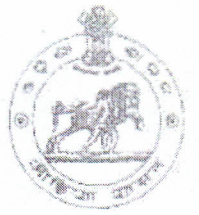

Madam/Sir,

In inviting a reference to the letters & subject cited above, I am to intimate that, it has been decided to conduct Social Audit of PMAY-G Scheme since the FY 2016-17 to 2020-21 for 5 years instead of 3 years decided earlier. The Process of Social Audit will be extended upto another 3 Days (6days+3days=9 days) which will be adjusted in the vacant slots of the NSAP and PM-Poshan Schemes incorporated in the Annual Social Audit Calendar, 2022-23. The VRPs team will be engaged as per the requirement in the GPs keeping in view the number of houses to be verified. The VRP will be entitled to get for a day's honorarium only after achieving the yardstick of at least completing social audit of 10 households per day and the honorarium will be released subject to 100% coverage of verification of Households in each G.P. during Social Audit Process.

In view of the above, the Capacity Building activities for VRPs needs to be completed by 5th November, 2022 positively before start of the Social Audit process and the Social Audit Calendar may be rescheduled accordingly at the district level.


