

Terms & Conditions:

- The firm should submit the documents in photocopy like **Registration Certificate, Current year Income Tax Clearance, Latest Service Tax return, up to date EPF & ESI deposit challan, labour license, gun license and present customer list** with the tender paper positively. In absence of the documents mentioned above, the tender will be rejected.
- Experience certificate should be enclosed for execution of similar nature of work.
- DSMS, Nayagarh will not be responsible for any occurrence like theft & missing of any articles while deployment of guards during the exhibition period.
- In case of any occurrence of theft, the Security Agency will conduct proper inquiry.
- During inquiry if it is found any fault or lapses on the part of security personnel for theft, the Security Agency will be responsible to pay the amount of loss towards theft of any article during the exhibition period from the premises.
- Arrangement of lodging, boarding & logistics of the guards at exhibition towns during the exhibition period will be the responsibility of the Security Agency.
- The required no. of security personnel & the time period of deployment will be intimated separately, well in advance of each exhibition.
- The tenderers are required to deposit an earnest money of in shape of Demand Draft / Banker's Cheque in favour of CE, DSMS, Nayagarh and payable at Nayagarh. The E.M.D amount of the successful tenderer will be kept with DSMS for one year. In case of any unsatisfactory work, delay in execution of work etc. the E.M.D amount will be forfeited as per the decision of the authority. Tenders without E.M.D shall be rejected.
- Cost of Tender paper (Non-Refundable) of Rs. 600/-INR + GST-18%=708/- in shape of Demand Draft / Banker's Cheque in favour of CE, DSMS, Nayagarh Payable at Nayagarh.
- Sanctions of any advance will not they considered. Full & Final payment will be made on completion of each event.
- The rate offered by the firm should valid for one year

- Valid service tax registration certificate number and copy of the return/amount deposited in the last year.
- Copy of the Pasara license.


