On recommendation of the Odisha Sub-ordinate staff selection Commission, Bhubaneswar vide their letter No-1904/OSSSC Dt-06.12.2022 and letter No-2020/OSSSC dt-07.12.2022 ,the following successful candidates are hereby appointed temporarily as Asst. Revenue Inspectors in regular scale of pay of cell-01 ,level-04 of the pay matrix of ORSP Rules-2017 with usual D.A and other allowances as admissible from time to time by Government from the date of their joining to the post subject to the following terms and conditions.

- 1. On their appointment, they are posted to the Tahasils as mentioned against their name and they shall submit their joining report to the concerned Tahasildars within 30 days from the date of receipt of this order & they should submit the following documents at the time of their joining before the concerned Tahasildars.
  - a) Self attested Xerox copy of all qualification certificates.
  - b) Two character certificates from the Gazetted Group-A or Group-B Officers.
  - c) Medical Certificate of fitness from a Medical Officer not below the rank of an Asst. Surgeon of any Govt. Hospital.
  - d) An oath of allegiance to the Constitution of India.
  - e) Certificate of Marital Status.
- 2. They are under probation for a period of two years and the appointing authority reserves the right to terminate the services of a probationers or extend the probation further period as considered necessary if during the probation period the work and conduct of the employee is found to be unsatisfactory or there are reasons to believe that the employee will not suitable for the post.
- 3. They shall be enrolled under the NPS contained in the OCS(Pension)Rules,2005 and OCS(Pension)Amendment Rules-2021 from the date of their appointment.
- 4. No Travelling Allowance is allowed for joining in the post.
- 5 Any document produced found to be contradictory or forged on verification at any time, their services will be terminated followed by initiation of prosecution.
- 6. The appointment is purely temporary and can be terminated at any time without assigning any reason thereof.
