The bidders are essentially required to enclose photo copies of the valid Registration Certificates, valid GST and PAN Card along with their bids tendered offers failing which their offers will not be taken into consideration. The bidders will be required to produce the original documents before the undersigned at the time of opening of the bids or at any stage as desired by this office.
2. Bid documents can be purchased from this office on payment of the cost with GST (18%) as mentioned above. The cost of bid documents and GST are non-refundable. Payment for the bid documents will be received in shape of B.C/B.D/D.D in favour of Executive Officer, NAC, Khandapada from any nationalized bank drawal at Khandapada branch or cash the deposited in the NAC office from 11.00 A.M. to 2.00 P.M. during working days only from Dt.19/12/2022 to Dt.30/12/2022 at 4.00P.M.
3. The bids will be opened on Dt.30/12/2022 at 5.00 P.M. in the office of the undersigned in presence of the respective bidders or their authorized representatives who intend to attend . If the office happens to be closed on the last date(s) of receipt and opening of the bids as specified, the bid will be received and opened on the next working days respectively at the same time and venue. The rates to be quoted shall be inclusive of all taxes, royalties, handling and deliver charges. No extra cost on any account whatsoever will be admissible conditional bids will be rejected immediately. The rates should be written clearly and legibly without any errors or over writings and both in figures and words. In case of difference of rates written in words and figures or due to other reasons, the rates quoted in words will be taken into consideration. Non-quoting of rates for any item will be treated as incomplete quotation. All incomplete bids will be rejected immediately during opening.
4. The bid will remain valid for a period of 120 days and will be extended on basis of the performances.
5. The bidder has to quote the fees/charges in percentage basis on the cost of the work assignment. Any tax levied by law such as service by the architect shall be payable by the client over and above the gross fees charged by the architect relation to the services provided.

6. Mode of payment

Stage – 1 On submission of DPR with the competent authority, 30% .of total fee payable.

2. After Technical sanction from the competent authority, 30% of total fee payable.

Stage – 2 On giving of Layout of building at site 30% of total fee payable.


Stage – 3 On completion of the project 10% of the total fee payable.

10. The Structural Design should be vetted by any Govt. Farm / Institution / College / School not below the rank of Asst. Professor (Civil).



9. Required consultancy services in allied field like landscape architecture interior architecture.


