

The bidders or their representative may remain present at the time of opening of the quotation failing which no complain/dispute in future shall be entertained.

This invitation for quotations is subjected to the terms and conditions appended below:


1. The quotations should be sent in Sealed Cover addressed to The CDO-cum-EO, Zilla Parishad, Nayagarh-752070. The words "Printing of Job Cards under MGNREGS" should be prominently written on the envelope containing the quotation.
2. The quotation should reach to this Office latest by 11.00 AM on dated 02.01.2023.
3. The Quotations will be opened on 02.01.2023 at 11.30 PM.
4. The contract shall be comprehensive and no extra charges will be admissible. The successful bidder is to be delivered at District HQ.
5. The order can be terminated by the CDO-cum-EO, Zilla Parishad, Nayagarh at any time without assigning any reason thereof. If the work of the L1 bidder is found to be unsatisfactory, the CDO-cum-EO, Zilla Parishad, Nayagarh will be at liberty to entrust the same to the next lowest bidder. In this connection, the decision of the CDO-cum-EO, Zilla Parishad, Nayagarh shall be final and binding upon the bidder.
6. Payment will be made on successful delivery of Job Cards as per govt. procedure.
7. Quotation received after due date and time will not be accepted.


