





TERMS AND CONDITION

1. The Sale and Receipt of the Bid documents shall starts from dt. 11/01/2023 to dt27/01/2023 and upto 1.00 P.M. on 27/01/2023 during the office hours i.e. 10.00 A.M. to 05.30 P.M. (Except Sunday and Holiday) on payment of cost of bids documents either in shape of cash or Demand Draft (non-refundable) issued from any Nationalized Bank drawn in favour of the Block Development Officer Bhapur payable at Bhapur
2. The sealed bid documents are to be delivered in the tender box having identification No-B.D.O (Bhapur)-01 and shall contain signed DTCN, attested copy of Registration Certificate, PAN Card, valid GST clearance certificate, valid Labor License, affidavit regarding authentication of documents, no relation certificate, document required as per the relevant clauses of the DTCN and special condition if any required amount of EMD in shape of NSC/KVP/POTD/ Bank deposit receipt of any Nationalized Bank duly pledged in favour of Block Development Officer, Bhapur without which bid will not be considered. The tenderer can also send their tender papers through registered post / speed post only to Block Development Officer, Bhapur such bids must be received on or before stipulated date & time as mentioned above. The bids received late will not be opened. The authority will not be held responsible for the postal delay if any or non-receipt of tender documents. The bidders are not required to write their name on the outer cover of the bid but they are required to write the name of work with name of office from which bid documents was issued.
3. The bid received will be opened on Dt. 27/01/2023 at 03.00 PM in the office of the Block Development Officer, Bhapur in the presence of the bidders or their authorized representative. If the office happens to be closed on the date or receipt/ opening of the bids as specified, the bids will be received/ opened on the next working day at 03.00 PM the same time & venue.
4. Other detailed can be had in the bidding documents. The bid should be duly filled & signed by the tenderer.
5. **Additional performance Security:** Range of difference between the estimated cost put to tender and BID amount. Below 5% no Additional performance security ,From 5% and above and below 10%, 50% of(Difference between estimated cost put to tender and bid amount)shall be deposited Additional performance Security by the bidder and from 10% and above 150% of (Difference between estimated cost put to tender and Bid Amount) shall be deposited Additional performance Security by the bidder in shape of fixed deposit receipt of schedule Bank / Kissan Vikas patra / post office savings bank account / N.S.C / post office time deposit account, duly pledged in favour of Block Development Officer, Bhapur along with the bid document failing which the bid will be summarily rejected.
6. Any clerical/ typical mistake may be ignore and if any may be intimated to the under signed as soon as possible.
7. The work should be completed within the stipulated period 06(Six) months of completion and in no case the time extension will be allowed except the reasons not attributable to contractors.
8. In order to ensure that the envelopes are properly sealed, the contractor can seal them with superglue and also add tamper proof tapes as additional precaution. The tender submitted in the wrong box shall not be taken into consideration.
9. The rate is exclusive of GST and the GST will be paid extra as applicable.
10. The authority reserves the right to reject any or all the bids without assigning any reason thereof.
