

- The Bidder must possess Compatible Digital Signature Certificate (DSC) of Class II or Class-III.
- Bids shall be received only "on line" on or before 5.00 PM of 20.03.2023 .
- Bids received on "on line" shall be opened at 11.00 AM on Dt. 21.03.2023 in the office of the Block

Development Officer, Nayagarh in the presence of bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the date of opening of Bids as specified, the bids will be opened on the next working day.

The cost of bid documents mentioned under col. 6 above are to be remitted online through a process as mentioned in the DTGN. Detailed information as contained in the DTGN shall have to be strictly adhered to while submitting the tender.

Engineer contractor desirous to avail the facility of exemption of EMD is required to submit an affidavit in original to this effect that he has not yet availed the facility for more than two works during the current financial year. The name of work for which the tender is being submitted must be mentioned in the affidavit.

Any tenderer desirous to avail any facility as per certain circular /orders of Govt. have to apply for the same in writing along with tender paper, claim at the time of opening of tenders or latter will not be entertained.

Any Corrigendum /Addendum will be displayed in the website [www.Orissa.Govt.in](http://www.Orissa.Govt.in) & <https://tenders.ori.nic.in>.

Additional performance security shall be obtained from the bidders when the amount is less than the estimated cost put to tender. In such an event only the successful bidders who have quoted less bid price/rates than the estimated cost put to tender shall have to furnish Additional Performance Security in shape of Demand Draft / Term Deposit Receipt pledge in favour of the Executive Engineer Nayagarh (R&B) Division within seven days otherwise the bid shall be cancelled and the security deposit shall be forfeited. Further proceeding for blacklisting shall be initiated against bidder.

The bidder is required to furnish work experience of the similar nature of work (building work with frame structure) having minimum work value (single work) of 40% of the tendered amount/ multiple works having not less than 20% of the tendered amount for each work as per SCHEDULE D1 with scanned copy of experience certificate issued by Engineer-in-charge not below the rank of Executive Engineer/ Superintending Engineer. The work should be executed within last 5 (five) financial years i.e 2017-18 to 2021-22. Non submission of work experience shall be treated as non-responsive and the bid shall be summarily rejected
