
Notice For Engagement Of Manpower At Field Level Offices

Applications are invited for filling up of vacancies in the post ICDS Supervisor and Junior Assistant (Statistics) by reengagement of retired employees for smooth functioning of DSWO and CDPO Offices of Nayagarh District.

So the retired employees as per Finance Deptt. O.M No. 24533/Dt.29.09.2022 may apply with the following conditions for consideration of engagement.


Applicants should apply to the undersigned by dt.24.03.2023 by Registered /Speed post positively.

1. The engagement is proposed to be for a period of two years or till regular posting of such base level post, **whichever is earlier**.
2. However, in case of non-filling up of such base level posts, their engagement may be further extended with the prior approval of the Department.
3. Under no circumstances should the engagement be continued beyond the approved timeline.
4. For the post supervisors, retired personal with past experience in W&CD Department, SSEPD Department, Health Department, School and Mass Education, SCSTM&BC Department, PR&DW Department may be considered. Preference may be given to Women.
5. For the post of SAs, any retired staff having experience of office work from any department may be considered. However; Preference may be given to those who are skilled with computers.
6. All retired employees should be posted only under the administrative control of the DSWO/CDPO offices where ever vacant to strengthen their working.
7. Person engaged as supervisor will be paid an amount of Rs.20000/-pm (level 9 as per ORSP Rules, 2017) and for Junior Assistants (Statistics) an amount of Rs.10000/- (level 4 under ORSP Rules, 2017) will be paid.
