

This invitation for quotations is subjected to the terms and conditions appended below:



3. The quotation will be opened on 11.30 AM on 03.04.2023.
4. The contract shall be comprehensive and no extra charges will be admissible. The successful bidder is to install the hoardings at GP HQ, Block HQ & District HQ.
5. The order can be terminated by the CDO-cum-EO, Zilla Parishad, Nayagarh at any time without assigning any reason thereof. 


