Stated quotation/tender are invited from interested reputed Travel Agencies/Tour or private individuals for providing one no. of non-AC diesel driven vehicle, i.e; Bolero /Marshal/Tata Sumo/Mahindra Max/Indigo & Indica eV2/Swift Dezire having sitting capacity not more than ten including driver, which shall confirm to the terms and conditions (Annexure-II) for official use in **ICDS Project, Gania** Department/Office on monthly rent basis.

1. The vehicle must be in road worthy condition shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance certificate, fitness certificate, valid contract carriage permit, proof up to date tax payment etc. which are mandatory plying of vehicle.
2. The driver of the vehicle must have a valid driving license for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
3. The driver should well behaved, gentle and obedient in nature.
4. A sum of Rs.5000/- (Rupees Five Thousand) only shall be deposited by intending bidders in shape of Account Payee Bank Draft drawn in favour of the **CDPO, Gania** and submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
5. The monthly rate of hire charge be quoted separately in general bid information (excluding fuel and lubricants)
6. The vehicle must achieve a fuel efficiently of **15 Km per liter** for Indigo, Dezire/**17 km per liter** for IndicaeV2 & **10 km per liter** for Bolero /Marshal/Tata Sumo & Mahindra Max respectively.
7. The upper ceiling limit for monthly hiring charges excluding POL is fixed at Rs 15,000/- (Rupees Fifteen thousands) only.
8. The details of the make and year manufacture of the vehicle, registration No. mileage (Kms. covered per liter) and name of the driver with driving license No. and period of validity should be specially provided in general bid information to be furnished with the Quotation/Tender (Annexure-III)
9. The Quotation completed in all respect should reach the undersigned on or before **03.04.2023 by 5.00 P.M** and shall be opened on **04.04.2023 at 11.00 A.M. in the office chamber of Sub Collector, Nayagarh** in presence of the bidders or their authorized representatives.
10. The application form of quotation/tender containing General bid information, term and condition for hiring of vehicle etc. will be available from **23.03.2023 to 03. 04. 2023** & can be downloaded from Odisha Govt. Website www.odisha.gov.in from Dt **23.03.2023 to 03.04.2023** in case the application form is downloaded from Govt. website. The applicant shall furnish in shape of cash for an amount Rs.100/- (One hundred) only towards the cost of application along with the application.
