The BLOCK DEVELOPMENT OFFICER, NAYAGARH, on behalf of Governor of Odisha invites Percentage Rate bids for the construction work in Single Cover System from appropriate Class of contractors as detailed in the table below registered with the State Governments and Contractors of Equivalent Grade / Class Registered with Central Government / MES / Railways for execution of the work. The proof of registration from the appropriate authority shall be enclosed along with the Bid. If successful, the bidder who has not registered under the state government has to register under the state PWD in appropriate class of eligibility before signing of the agreement.

3. Govt. of Odisha has introduced e-payment gateway in to the portal for payment of cost of Bid and Bid Security / Earnest money Deposit. The process of using e-payment gateway is mentioned in the "Procedure for electronic receipt, accounting & reporting of cost of Tender paper & EMD in submission of Bids" of DTCN.
4. The Bid documents will be available in the www.tendersorissa.gov.in from 11.00 AM of 03.06.2023 to 5.00 PM of 15.06.2023 for Online Bidding.
5. The Bidder must possess Compatible Digital Signature Certificate (DSC) of Class II or Class-III.
6. Bids shall be received only "on line" on or before 5.00 PM of 15.06.2023.
7. Bids received on "on line" shall be opened at 11.00 AM on Dt. 16.06.2023 in the office of the Block Development Officer, Nayagarh in the presence of bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the date of opening of Bids as specified, the bids will be opened on the next working day.
8. The cost of bid documents mentioned under col. 6 above are to be remitted online through a process as mentioned in the DTCN.
9. Detailed information as contained in the DTCN shall have to be strictly adhered to while submitting the tender.
10. Engineer contractor desirous to avail the facility of exemption of EMD is required to submit an affidavit in original to this effect that he has not yet availed the facility for more than two works during the current financial year. The name of work for which the tender is being submitted must be mentioned in the affidavit.
11. Any tenderer desirous to avail any facility as per certain circular /orders of Govt. have to apply for the same in writing

12. along with tender paper, claim at the time of opening of tenders or latter will not be entertained.
 13. Any Corrigendum /Addendum will be displayed in the website www. Orissa. Govt. in & https. // tenders.ori.nic.in.
 Additional performance security shall be obtained from the bidders when the amount is less than the estimated cost put to tender. In such an event only the successful bidders who have quoted less bid price/rates than the estimated cost put to tender shall have to furnish Additional Performance Security in shape of Demand Draft / Term Deposit Receipt pledge in favour of the Block Development Officer, Nayagarh within seven days otherwise the bid shall be cancelled and the security deposit shall be forfeited. Further proceeding for blacklisting shall be initiated against bidder.
 The State Government is pleased to fix the following rate of Additional Performance Security.
