Sealed quotations are invited from the intending Register Printing Press/ Supplying Agencies for printing and supply of Marriage Register & Leaflets on Prohibition of Child Marriage Act, Child Labour Act, Protection of Children from Sexual Offence Act and Mission Vatsalya Scheme to the DCPO, Nayagarh.

The detailed quotations shall be received by the Office of the District Child Protection Officer, Nayagarh on 8.6.2023 to 19.6.2023 at 3.00 P.M. only through registered post/Speed Post. The same will be opened in presence of the District Level Purchase Committee at 4.00 P.M. on 21.6.2023 at the O/o ADM, Nayagarh. The bidders or their representatives may remain present at the time of opening of the quotation failing which no complain/dispute in future shall be entertained.

The bidders are to quote unit price of a particular item along with GST, Transportation Fees & any other charges as admissible.

The invitation for quotations is subject to the terms and conditions appended below:-

1. The quotations should be sent in Sealed Cover addressed to District Child Protection Officer, Nayagarh-752069. The words "Short quotation call notice for printing and supply of Marriage Register & Leaflets on Prohibition of Child Marriage Act, Child Labour Act, Protection of Children from Sexual Offence Act and Mission Vatsalya Scheme" should be prominently written on the envelope containing the quotations.
2. The quotation should reach to this Office latest by 3.00 P.M. on dated 19.6.2023.
3. The quotations will be opened on 21.6.2023 at 4.00 P.M.
4. The contact shall be comprehensive and no extra charges will be admissible. The successful bidder is to supply the items to DCPO, Nayagarh within 7 days after placing order.
5. The order can be terminated by the DCPO, Nayagarh at any time without assigning any reason thereof. If the work of the L1 bidder is found to be unsatisfactory, the DCPO, Nayagarh will be a liberty to entrust the same to the next lowest bidder. In

this connection, the decision of the DCPO, Nayagarh shall be final and binding upon the bidder.

6. Payment will be made on successful completion of the work as per Govt. procedure.
7. Quotation received after due date and time will not be accepted.
8. The DCPO, Nayagarh reserves the right to reject any quotation in whole or in part without assigning any reason thereof.
9. Quotation that does not satisfy the term & conditions are liable to reject summarily.
10. The quotation should be valid for one year from the date of issuance of Supply Order.
11. Quantity of Marriage Register & Leaflets on Prohibition of Child Marriage Act, Child Labour Act, Protection of Children from Sexual Offence Act and Mission Vatsalya Scheme may increase or decrease marginally.
12. Bidder must furnish full data and information as required.
