## TERM AND CONDITION

- The Sale and Receipt of the Bid documents shall starts from Dt.23-04-2021 and close on Dt.07-05-2021 during the office hours i.e. 07:00 A.M. to 01.00 P.M. (Except Saturday, Sunday and Holidays) on payment of cost of bids documents either in shape of cash or Demand Draft (non-refundable) issued from any Nationalized Bank drawn in favour of the **Block Development Officer, Nayagarh** payable at Nayagarh.
- 2- The sealed bid documents are to be delivered in the in the tender box having identification No. B.D.O(Ngr.)-03 and shall contain signed DTCN, attested copy of Registration Certificate, PAN Card, valid GST clearance certificate, valid Labour License, affidavit regarding authentication of documents, no relation certificate, document required as per the relevant clauses of the DTCN and special condition if any required amount of EMD in shape of NSC/KVP/POTD/ Bank deposit receipt of any Nationalized Bank duly pledged in favour of **Block Development Officer Nayagarh** without which bid will not be considered. The tenderer can also send their tender papers through **registered post / speed post only** to **Block Development Officer Nayagarh** such bids must be received on or before stipulated date & time as mentioned above. The bids received later shall not be considered. The authority will not be held responsible for the postal delay if any or non- receipt of tender documents. The bidders are not required to write their name on the outer cover of the bid but they are required to write the name of work with name of office from which bid documents was issued in bold capital letters.
  - 3- The engineering contractor desires of having EMD exemption benefit must have to produce an affidavit to the effect that, they have not availed such exemption for more than three times during this financial year. Also the engineering contractor will produce his/her Original license at the time of opening of tender so that the tender opening authority will enter the exemption of EMD in his/ her license failing which tender shall liable for rejection.
  - 4- The bid received will be opened on **Dt.07.05.2021 at 12:00 Noon** in the office of the Block Development Officer, Nayagarh in the presence of the bidders or their authorized representatives. If the office happens to be closed on the date or receipt/ opening of the bids as specified, the bids will be received/ opened on the next working day at the same time & venue.
  - 5- The details can be had in the bidding documents. Which should be duly filled & signed by tenderer.
  - 6- Special clause:- Additional performance security shall be deposited by the bidder when the bid amount is unbalanced i.e. less than 15% of the estimated cost in such an event the bidder shall deposit the additional performance security to extend of the differential cost of quoted bid amount and the estimated cost put to tender in shape of fixed deposit receipt of schedule Bank / Kissan Vikas patra / post office savings bank account / N.S.C / post office time deposit account, duly pledged in favour of **Block Development Officer, Nayagarh** along with the bid document failing which the bid will be summarily rejected.
  - 7- The authority reserves the right to reject any or all the bids without assigning any reason thereof.
  - 8- The work should be completed within the stipulated period 9 (Nine) months of completion and in no case the time extension will be allowed except the reasons not attributable to contractors.
  - 9- In order to ensure that the envelopes are properly sealed, the contractor can seal them with superglue and also add tamperproof tapes as additional precaution.
  - 10- The rate is exclusive of GST and the GST will be paid extra as applicable.
