- [01] Tender schedules in the prescribed proforma [downloaded from the official website of Nayagarh District (<http://nayagarh.nic.in>)] alongwith Tender Paper cost @ Rs.6,000.00 for New Construction of Subcenter at K.K. Nuagaon in shape of Bank Draft (from any Nationalized Bank payable at Daspalla drawn in favour of Block Development Officer, Daspalla) from the registered Class "C" & "B" contractors should reach at Panchayat Samimiti, Daspalla from 24.05.2021 7.00 AM to 04.06.2021 10.00 AM through Registered Post/Speed Post only.
- [02] The estimated cost put to Tender of the work tendered is Rs.29,17,956.00 (Rupees Twenty-nine Lakh Seventeen Thousand Nine Hundred Fifty-six)only.
- [03] An affidavit (From Executive Magistrate only) in lieu of Additional Performance Security Deposit (APSD) will be submitted by the successful bidder for the cost of less quoted in percentage of the amount put to Tender before signing of the agreement of the contract (vide Works Department Letter No-14459/W, Dt-20.09.2018, Govt. of Odisha Works Department) as per Office Memorandum No-4559, dt- 05.04.21 of Works Department Govt. of Odisha modification to APS will be followed as detailed bellow:

- [04] All the tenders where rate quoted is more than 15% or less than the scheduled rate will be rejected.
- [05] S.C./S.T. tenderers can avail facilities as per Govt. circular.
- [06] The bidders shall have to furnish an affidavit (From Executive Magistrate only) alongwith the bid regarding the authenticity of the bid document.

- [07] L -1 bidder does not turn up for agreement after finalization of tender, then he/she shall be debarred from participation in bidding for three years and action will be taken to blacklist the bidder. In that case L -2 bidder if full fill, other required criteria would be called for drawing agreement for execution of work subject to the condition, that L -2 bidder negotiate at par with the rate quoted by the L-1 bidder otherwise tender will be cancelled.
- [08] The rate to be quoted by the contractor shall be excluding GST. The implementation of the GST rules by the Govt. of Odisha is to be accepted by the bigger at any point of time.
- [09] If the rate quoted by the tenderers is found to be same, tender committee will decide the tender
- [10] The work is to be completed within 120 days from the date of issue of work Order.
- [11] The plan, specification and special condition for the work can be seen from the official website of Nayagarh District (<http://nayagarh.nic.in>).
- [12] The authority reserves the right to reject any or all the tenders without assigning any reason thereof.
- [13] Each tender must take the form of a definite % of rate on estimated cost will be considered.
- [14] All rates should be for finished items of work unless and otherwise mentioned in the tender notice.
- [15] All taxes, fees, royalties etc. payable under the local rules including GSTIN, income tax (PAN) and Entry fees will be paid by the contractor.
- [16] The contractor should be abided by the fair wages clause in force by the Government and shall not pay less than the fair wages fixed by the Government to the labourers Engaged by him on the work.
- [17] The tender will not be considered unless the tenderer encloses true certified copy of Valid and up-to-date GSTIN certificate and income tax (PAN CARD) clearance certificates along with his tender and the original certificates are to be produced before the officer of the Department at the time of opening of the tender or whenever required.
- [18] The Department will not be responsible, if there would be any delay in transit in receipt of the Tender Paper by the intending tenderers. Similarly, tenders received after scheduled date and time due to postal delay will not be considered on any account even if the tenders were dispatched by the tenderer before the due date.
- [19] Telegraphic tenders will not be considered on any account.
- [20] Item of work not covered by the tender will be paid at the current Schedule of rates and those not covered by the Schedule of Rates will be paid on actual analysis approved by the competent authority.
- [21] The rate of percentage in the tender should be written both in words and figures and in case of Any discrepancy the rate written in words will prevail.

- [22] The right is reserved to make such increase or decrease in the quantities or items of works mentioned in the schedule attached to the tender notice as may be considered necessary for satisfactory completion of the contract work and such increase or decrease shall, in no way, invalidate the contract or rates. The contractor shall not be entitled to any compensation on this account except extension of time where considered necessary.
- [23] The tenderer whose tender is accepted shall forthwith, upon written intimation being given to him of acceptance of his tender, make an APSD as will be intimated for the due fulfillment of contract in the office of the undersigned. The APSD should be taken as security for the fulfillment of the contract.
- [24] The tenderers are required to submit a list of works which are in hand at the time of submitting their tender in the following format.
- a. Name of the work.
 - b. Name and particulars of division where the work is being executed.
 - c. Amount of the work.
 - d. Position of the work in progress.
 - e. Remarks.
- [25] That for the purpose of jurisdiction in the event of dispute, if any, of the contract would be deemed to have been entered into at the district headquarters of the work site and neither party to the contract or agreement will be competent to bring a suit in regard to the matter covered by the agreement or contract at any place outside the State of Orissa.
- [26] The contractor will have to furnish a certificate along with the tender about the names of his relatives employed under the Panchayati Raj & Drinking Water Department, in charge of Execution of the work.
- [27] No compensation for any damage done by rains or by similar action during the execution of work will be paid.
- [28] Letters found in the tender box intimating modification to the tenders already submitted will not be considered at all.
- [29] The contractor will make at his own cost housing accommodation for and medical aid to the Labourers engaged on the work.
- [30] The contractor shall make arrangements at his own cost at the work site for the proper storage of the materials made over to him.
- [31] The tender which is not in the prescribed proforma and is not strictly to the terms and conditions of the tender notice and specification is liable for rejection.
- [32] The Contractors will use Sail Rod for reinforcement work and 43 grade OPC cement like OCL, Ultra tech, Konark, ACC for execution of the work.
- [33] The agency has to make light arrangement, Traffic diversion, water supply etc. at site if required at their own cost.

- [34] In case of concrete works, it will be the responsibility of the agency to protect the work site day and night from traffic movement till end of curing period for achieving proper strength.
- [35] The authority reserves the right to deduct any amount from the bills for any type of defective works and the agency may be directed to completely or partly dismantle the defective work and rectify or re-do as per specification.
- [36] The agency will be sole responsible for quality and quantity of work as specified in tender schedule and as measured and accepted for bills. If any discrepancy or recovery arises or detected by any agency later on, the same will be binding on the contractor for rectification or recovery at his own cost.
- [37] The lowest tendered shall submit **the quality test certificate report of materials** used in work. as and when required.

Special Conditions Percentage Rate Contract.
Amendment to para-3.55 Vol.I-Dt.17.05.2006.

Following new provision shall be made to quote the rate of work by the contractor
3.5.5 (V) Percentage rate contract.

Percentage contract will be in addition to item rate .lump sum contracts etc in such contract the schedule of quantities shall mention estimated rate of such item & amount there to. The contractor has to mention percentage excess or less over the estimated cost (in figures as well as words) in the prescribed format appended to the tender document .The contractors participated in the tender for more than one work may offer conditional rebates. Rebate offer submitted in separate sealed envelope shall be opened declared & recorded first. The rebates so offered, shall be considered after opening of all package called in the same tender notice. The contractor who wish to tender for two or more works shall submit separate tender for each. Each tender shall have the name & number of the works to which they refer written on the envelope.

The adopted format for percentage rate is same as that of the form adopted for item rate tenders but the word " item rate " shall be replaced by "percentage rate " and the contract form may be named as P-I . In this form time is the essence. The contractor is required to maintain a certain rate of progress specified in the contract. The contract can also be terminated with penalty when the progress of work is not as per condition of contract. The quantity mention can be increase or reduce to the extent 10% for individual items subject to a maximum of 5% over the estimated cost. If it exceeds the limit stated above prior approval of competent authority is mandatory before making any payment. The period of completion is fixed and cannot be altered except in case of exceptional circumstances with due approval of next higher authority.

In case of percentage rate tenders, only percentage quoted shall be considered. Percentage quoted by the contractor shall be accurately filled in figure and words, so that there is no discrepancy. If any discrepancy is found in the percentage quoted in words and figure then the percentage quoted by the contractor in words shall be taken as correct. If any discrepancy is found in the percentage quoted in percentage excess/less and total rate quoted by the contractor then percentage will be taken as correct. The percentage quoted the tender without mentioning excess or less & not supported with the corresponding amount will be treated as excess. The contractor will write percentage excess or less up to one decimal point only, if, he writes the percentage excess or less up to two or more decimal point, the first decimal point shall only be considered without rounding off. Where the contractor has omitted to quote the rates either in figures and words the officer opening the tender should record the omission.

Bills for percentage rate tender shall be prepared at the estimated rates for individual items only and the percentage excess or less shall be added or subtracted from the gross amount of the bill.





Percentage contract will be in addition to item rate .lump sum contracts etc in such contract the schedule of quantities shall mention estimated rate of such item & amount there to. The contractor has to mention percentage excess or less over the estimated cost (in figures as well as words) in the prescribed format appended to the tender document . The contractors participated in the tender for more than one work may offer conditional rebates. Rebate offer submitted in separate sealed envelope shall be opened declared & recorded first. The rebates so offered, shall be considered after opening of all package called in the same tender notice. The contractor who wish to tender for two or more works shall submit separate tender for each. Each tender shall have the name & number of the works to which they refer written on the envelope.
