



7. EMD. : Rs. 5,000/- (Rupees Five Thousand Only) per tender. The earnest money deposit will be paid in the shape of demand draft only in favour of : Medical Superintendent, B. M. 9. General Conditions for supply of Drugs/Chemicals & Consumables etc. :-

- a) The supplier should have minimum 05 nos. End User's Certificate for last 5 years from 5 Districts issued by the concerned authorities for the years w.e.f 2016-2017 to 2020-2021 in the name of the distributor with 5 nos. Order copies per year w.e.f 2016-2017 to 2020-2021 from 5 Institutions and the bidder must submit the end users / market standing certificate from the concerned authorities to the effect that, he supplied them medical drugs/ chemicals/ equipments/ instrument/ BMW articles and Bedding & Clothing articles etc.
- b) The supplier must submit the IT return Acknowledgement copy for last 3 years minimum.
- c) The supplier must submit the audited balance sheet for last 3 years.
- d) The supplier must submit the authorization certificate from the manufacturer against the individual items along with valid ISO certificated.
- e) The average turnover of the company should be 5 Crores each year of the last 3 years.
- f) At the time of supply, supplier must submit a test report of the batches being supplied from a NABL / Govt. approved Laboratory that the supplied drugs are of standard quality based on which the drugs can be used or distributed.
- g) The authority will also do random testing of the supplied drug, If required, for which quality testing , packing and forwarding charges if any, will be borne by the supplier.
- h) The supplied should be made in less number of batches (Less than 3) and maximum 2 phases and should arrived at the Warehouse with remaining self life of at least 5 / 6th of the stipulated total self life from the date of manufacturing of the product.
- i) The supply should be made in good packing condition and labeling **"ODISHA GOVT. SUPPLY, NOT FOR SALE"**, MRP should not be mentioned anywhere in s strip/ Box/ ampoule/ Vial etc.
- J) All should be super-scribed "as per the subject supply for drugs & consumables under respective scheme" and bill should be prepared on the values of the goods + GST and then entry tax if applicable on total value.

K) GST will paid be paid extra. Entry tax if, any should paid by the supplying farms at the entry points which will be reimbursed to the farm along with payment for the supply on production of valid entry tax payment received in Original attached to the bill of supplied items .

L) All Bidders should registered in ODISHA GST Registered only.

M) All bills should contained GST Nos. so far as GST is concerned .

N) After supply of all the batches of all items/ drugs will be sent for quality testing to different testing laboratories. If any, any batch of any item / drug comes out to be NOT OF STANDARD QUALITY (NSQ)the supplier of farm will be replace the full stock of that batch No. and take back available the NSQ stock from this Health Institution at his own cost. No payment will be made for the replacement of the NSQ drugs with good quality drugs.

O) If the firm / supplier does not replace the full stock of that batch of then item declared NSQ within 1 month of issue of the letter , he will be derecognized for that product and no payment will be made to him for that product or if he has taken the payment of that product , the cost of that batch NSQ drugs will be deducted from any payment due for him and no further orders will be given to him for that product. If any , payment has been made to him for the same product, then the same must be refunded by the Bidder with in 7 days of information at their own cost.

P) Liquidated damage will be charged @ 0.5% per week beyond 30 days up to 90 days from the date of issued of the purchased order.


