The term and conditions

- 1.The Electoral Roll for each ULBs shall be printed in 30 copies in 60 GSM Cream wove paper. This shall be printed with 50 entries on first page of every ward with heading on the Top and qualifying date of voter, date of publication of Draft electoral roll, Signature and Seal of Election Officer and page at the bottom of each page of Electoral Roll. In the subsequent pages of every ward there shall be 62 entries.
- 2.The Electoral roll shall be printed in Odia and each page of the electoral roll shall be of A-4 size.
- 3.The selected press (es)/DTP firm(s) shall have to deposit one percent of the total value in shape of cash as security deposit with **District Nizarat Section, Collectorate, Nayagarh** on the day of execution of agreement prior to issue of printing orders.

4. The Press(es)/ DTP Firm(s) shall supply 4 (four) copies of Preliminary, Draft, Final Electoral Roll and print one Master Copy and 30(thirty) xerox copy of Electoral Roll on A4 size paper either by printing/DTP and one soft copy in CD, to the office of the **Collector & District Magistrate, Nayagarh** on the scheduled date as per printing order. They shall be responsible for cent percentage accuracy of printing for which they shall have to make their own arrangements for proof reading.

5. The Press (es) /DTP Firm(s) shall without fail print the name (s) of their Press(es) /DTP Firm(s) at the bottom of each page of the Electoral roll.

Sub: Printing of Electoral Rolls for General Elections to  
Urban Local Bodies, 2022 -  
Finalisation of printing firms.

Madam/ Sir,

I am directed to say that the work of printing of Electoral Rolls in required numbers shall be done under the direct supervision of the District Magistrate as Electoral Registration Officer.

2. Sufficient time may not be available after publication of the final Electoral Roll for inviting quotations / tenders and completing the required formalities for awarding printing orders. The Commission therefore directs that as a measure of abundant caution the District Magistrates shall take advance action as follows:-

- I. Quotations / Tenders as necessary may be floated inviting offers from local press(es)/DTP firms to prepare 4 (four) copies of Preliminary, Draft, Final Electoral Roll and print one Master Copy and 30 (thirty) Xerox copy of Electoral Roll on A4 size paper. However the approved rate of the State Election Commission (Annexure-IV) or the rate fixed through quotation which is lower will be accepted. One or more press(es)/DTP firms as may be expedient may be finally selected having

regard to its / their reliability, printing capacity and quality of machines and past experience in successfully executing important printing works of Government. In case the work is assigned to more than one press, efforts should be made to award the work at an uniform rate. The entire printing work has to be as per instruction/date line issued by the Commission.

The Assembly Constituency wise Electoral Roll Database in Excel Format for the entire District will be supplied by the Commission. The Preliminary Electoral Roll shall be prepared from the same database.

- II. The Electoral Roll for each Ward/ULB shall be printed in odia language with 50 entries on the 1<sup>st</sup> page with heading and 62 entries in subsequent pages without heading. The sample of 1<sup>st</sup> page and 2<sup>nd</sup> page of Electoral Roll are enclosed as Annexure-I & II.
  - III. Before issue of the printing order, an agreement in the prescribed in Form (Annexure-III) will have to be executed and security amount of one percent of the total value in shape of cash shall be deposited by the selected press(es)/DTP firm(s).
  - IV. The selected firms shall be responsible for cent percent accuracy of printing and asked to make its own arrangement for proof-reading. However as a measure of abundant caution some responsible Officers/ Staff shall also be assigned to supervise the preparation/printing work and be asked to ensure cent percent check of proof corrections.
  - V. The DTP firm(s) shall without fail print the name(s) of their DTP firm(s) qualifying date of voter, date of publication of Draft Electoral Roll, Signature and Seal of election Officer and page at the bottom of each page of the Electoral Roll.
3. The rates of printing of Electoral Rolls, binding charges, cover page and index page and have been given in the enclosed statement (Annexure – IV). The rate is applicable for 4 (four) copies of Preliminary, Draft, Final Electoral Roll and print one Master Copy and 30 (thirty) Xerox copy of Electoral Roll on A4 size paper.

4. Floating of Quotations / Tenders inviting offers from local DTP firms and selection of firms shall be completed by 20.12.2021 for smooth completion of printing of Electoral Roll under intimation to State Election Commission.

5. The DTP firm(s) shall supply 4 (four) copies of Preliminary, Draft, Final Electoral Roll and print one Master Copy and 30 (thirty) Xerox copy of Electoral Roll on A4 size paper and **one soft copy**.

6. After printing and binding of the Electoral Roll, the total cost of printing in respect of the Corporations/Municipalities/NACs is to be worked out taking into account the cost of the printing charges of Master copy, Xeroxing and binding charges etc. and the total cost so arrived will be divided by the total number of copies printed/Xeroxed to arrive at the cost price of one copy of the Electoral Roll.

7. While one set of the Electoral Roll has to be given free of cost to recognized National Political Parties/State Party, other copies may be sold at the cost so fixed by the District Magistrate and the realization from the sale of these Electoral Rolls will be credited into account "0070-Other Administrative Service-02-Elections-101-Sale Proceeds of Elections Forms and documents."

8. As per the guidelines of ECI the following foot note shall be printed in the final Electoral Roll.



AN AGREEMENT made on this the .....day of

the ..... Press(es)/DTP repugnant to the context including his heirs  
administrators, executors or assignees) of the one part and District Magistrate  
.....(hereinafter referred to as the District Magistrate) of the other part,  
whereby it is mutually agreed as follows, that is to say :-

1. The Press/DTP firm Contractor shall print and supply the copies of Electoral Roll at the rates and during the period specified in the agreement.
2. The number of pages stated in the agreement shall be deemed to represent merely the approximate quantities estimated to be required by District Magistrate of the Districts and the District Magistrate shall not be liable to pay any compensation to the press contractor unless the number of pages required from him falls below the number stated in the said schedule by more than the twenty percent. The Press/DTP firm contractor shall, if required by the District Magistrate of the Districts supply not more than twenty percent of the number of pages stated in the agreement in excess of such number at the rates fixed.
3. The Press/DTP firms Contractor shall do his own proof reading without any additional remuneration and without reference to the District Magistrate of District and shall be responsible for supplying correct master copy and other copies in accordance with the database supplied to him. If the master copy and other copies are found to contain mistakes which did not occur in the database supplied to the press, they may be rejected or reprinted at the cost of the Press/DTP firms.
4. The District Magistrate at his discretion may authorize any Officer or officers to supervise the proof corrections for preparation and printing the master copy, in which event the Contractor shall afford required facilities to such officers for performing their duties.
5. The paper of the Electoral Roll shall be inferior to 60 GSM. If and whenever the Contractor fails to deliver the printed master copy and other

copies of Electoral Rolls within the due time for delivery, the District Magistrate shall be at liberty to deduct at the rate of two percent of the amount of the Contactor's bill for each days' delay beyond the said time.

6. If the final copies be rejected under clause 3 here of, the District Magistrate may require the press contractor to reprint the master copy and other copies of "Electoral Roll" at his own cost or may arrange to have them reprinted/DTP by another press at the cost of the press(es)/DTP firms, and may cancel the contract in respect of any work of which the manuscripts are not already in the hands of the press contractor. If in the printed master copy of the "Electoral Roll" any matter has been omitted or incorrectly entered, with reference to the database, supplied to the press(es)/DTP firms contractor, corrected copy shall be supplied by the press and entire cost of reprint shall be borne by the press.

7. The press(es)/DTP firms contractor shall not transfer, assign or sublet this present contract or any part thereof save with the consent of the District Magistrate.

8. The Contractor shall admit the District Magistrate or any officer authorized by him to the premises of his firm with a view to ascertain the progress of the work.

9. The Press(es)/DTP firms shall neither give any copy of the "Electoral Roll" or any part thereof to any person other than the District Magistrate nor shall print any copy in excess of the number ordered by the District Magistrate, or by any officer specially authorized for purposes of this clause in writing in this behalf by the District Magistrate. He shall not also permit any unauthorized use to be made of any of the proofs of the "Electoral Roll" by any person whatsoever.

10. The press(es)/DTP firms shall give delivery of all the copies of "Electoral Roll" along with soft copies duly arranged, to the person authorized by the District Magistrate in his office.

11. It is hereby expressly agreed that in case of default on the part of the Contactor to deliver the "Electoral Roll" along with soft copy duly arranged, in time and there is reasonable apprehension that he would not be able to so

deliver, the District Magistrate shall be at liberty to cancel the contract without any notice whereupon the Contractor shall be bound to return the data use immediately and the District Magistrate shall be at liberty to get the work executed elsewhere and recover the additional cost, if any incurred thereby from the Firm Contractor .

12. The Press(es)/DTP firms hereby agrees to make a deposit of 1% of the total value as security, which shall be refunded to him after the delivery of the printed Rolls.

13 If in the matter of this agreement any dispute or difference arises the same shall be referred to State Election Commission, Odisha whose decision shall prevail and be final and binding on the parties.
