Units/ Authorized suppliers as per tender specification for "**Supply of Sports Goods/equipments, Deep fridge, Ice making machine, First aid & Physiotherapy equipments**" for the use of inmates of Sports Hostel, Nayagarh during the year, 2022-23 having valid GST certificate, Dealership certificate, PAN card required test certificate in conformity with detailed tender call notice. 
#### **Terms & Conditions**

- Interested bidders may submit their sealed tender documents in the prescribed format mentioning "**Supply of Sports Goods Sports Goods/equipments, Deep fridge, Ice making machine, First aid & Physiotherapy equipments**" on the cover of the envelope to the District Sports Officer, Nayagarh by **27.06.2022 up to 5.00 P.M.** Bidders are required to submit technical bid and financial bid in separate envelope enclosed in a common envelope mentioning "**Supply of Sports Goods and Other materials**" on the cover of the envelope through **Regd. Post/Speed Post** Only addressing to the **District Sports Officer, Collectorate, Nayagarh, At/Ps/Po/Dist- Nayagarh-752069**.
- The Technical & Financial Bid will be opened on **28.06.2022 at 10:30 A.M.** in the presence of the bidder or their authorized representative in the office chamber of the **Additional District Magistrate, Nayagarh**.
- The Tender paper should be filled in properly by the tenderer without correction/overwriting. The rate quoted by the tender should be final and the tenderer should not be allowed to change anything under any circumstances. The Tender paper should be completed in all respects. Incomplete tender paper is liable to be rejected.
- In absence of any documents as above the Tender Paper will be liable for rejection by the Tender Committee.
- Tender receive after due date and time will not be accepted. **District Sports Officer, Nayagarh** shall not be responsible for Postal delay or similar reasons. No Tenders sent through an electronic means shall be accepted. Any corrigendum/addendum, if any will be uploaded in the above mentioned website.

- The tenderer are required to deposit the EMD Amount of **Rs. 5,000/- (Rupees Five Thousand)** only in shape of Bank Draft drawn in favour of **District Sports Officer, Nayagarh** Payable at Nayagarh alongwith the tender documents (subject to refund of the same to the unsuccessful tenderer) after selection/ finalization by the Tender Committee.
- Bidder must submit the copy of PAN Card, Income Tax Return of current Financial Year (for Assessment year, 2022-23), GST Registration Certificate.
- The District Sports Office, Nayagarh will be considered strictly on the basis of the quality of the sample of sports goods submitted by the bidders which will be evaluated by the Tender committee. If the Technical Bid is found complete in all respect, then only financial bid will be opened, otherwise Financial Bid will be returned to the bidder without opening it.
- The purchase order shall be placed as per actual requirements as well as availability of funds, order shall be placed with the approved supplier(s) taking into consideration of trainees strength.
- **The selected tenderer should supply the materials in the Office of the Sports Hostel, Nayagarh within 25 days (Twenty Five days) from the date of issue of supply orders, strictly as per the sample approved by the purchase committee.**
- In case of any complaint regarding the supplied materials the decision of the Addl. District Magistrate, Nayagarh shall be binding and final. Who shall obtain a report from the recipients then the suppliers shall be replace the same at his/ her own cost.
- If the supplier failed to supply the material within the stipulated period and as per the approved samples, the EMD will be forfeited and the purchase order will be cancelled.
- Payment shall be made after random inspection of supplied materials by the inspection team and if found satisfactory. The unsuccessful tenderer shall arrange to take back their samples and E.M.D at their own risk.
- The Authority reserves all the right to accept or reject any or all tender without assigning any reason thereof.
- In absence of any documents as above the Tender Paper will be liable for rejection by the Tender Committee.
- In case of any dispute arises between the supplier & purchaser shall be tried to resolve amicably by mutual understanding if the party fails to resolve the dispute within 28 days shall be settled through arbitration under the Jurisdiction of Nayagarh Court only as per Indian Arbitration and Conciliation Act-1996.
