Sealed quotation/Tenders are invited from interested reputed Travel Agencies/Tour Operator or Privet individual for providing One no of AC diesel driven white colour Bolero or similar vehicle having seating capacity not more than seven including driver, which shall confirm the terms and conditions in all respect for Official use in Tahasil Office, Ranpur under Revenue and Disaster Management Deptt On monthly rent basis.

1. The vehicle must be in Road worthy condition/shall not be more than 3 months old from the date of initial registration in white colour and must have valid registration certificate, Insurance Certificate, Fitness Certificate, valid contract carriage permit, proof of up to date tax payment etc. which are mandatory for plying of vehicle.
2. The driver of the vehicle must have valid driving license for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
3. The driver should be well behaved, gentle and obedient in nature.
4. A sum of Rs 5000/- (Rupees Five Thousand) only shall be deposited by the intending bidders in shape of account payee bank draft drawn in favour of the Tahasildar, Ranpur and submitted along with the tender as security deposit. After completion of tender process the amount will be refunded to unsuccessful bidders.
5. The monthly rent of hire charge be quoted separately in the general bid information (Excluding fuel and lubricants).
6. The vehicle must achieve a fuel efficiency of 12 Kms per liter.
7. The details of the make and year of manufacture of the vehicle, registration no, mileage (Kms covered per liter) and name of the driver with driving license number and period of validity should be specifically provided in the general bid information to be furnished with the quotation /Tender.
8. The quotation completed in all respect should reach the undersigned on or before 19-09-22 by 5 P.m and shall be opened on the next day i.e 20-09-22 at 11a.m in the presence of the bidder or their authorized representatives.
