



TERM AND CONDITION

- 1- The Sale and Receipt of the Bid documents shall starts from Dt.,,,,,,,11.2022 and close on Dt.,,,,,,-11.2022 at 11.00 A.M. (Except Sunday and Holiday) on payment of cost of bids Rs 6,000/- (Rupees six thousands) only documents either in shape of Demand Draft (non- refundable) issued from any Nationalized Bank drawn in favour of the Block Development Officer, Nayagarh payable at Nayagarh.
- 2- The sealed bid documents should contains Singed DTCN, Aattested copy of Firm Registration Certificate,PAN Card, Valid GST clearance certificate, An amount of Rs 50,000/- (Rupees fifty thousands) only towards EMD (refundable) in shape of Bank Draft from any Nationalized Bank in favour of Block Development Officer Nayagarh. Without which bid will not be considered.
- 3- The tenderer can also send their tender papers through registered post / speed post/By hand(drop box) only to Block Development Officer Nayagarh such bids must be received on or before stipulated date & time as mentioned above. The bids received late will not be opened. The authority will not be held responsible for the postal delay if any or non-receipt of tender documents. The bidders are not required to write their name on the outer cover of the bid but they are required to write the name of work with name of office from which bid documents was issued.
- 4- The bid received will be opened on Dt.....11.2022 at 12:30PM in the office of the Block Development Officer, Nayagarh in the presence of the bidders or their authorized agents wish to attend. If the office happens to be closed on the date or receipt/ opening of the bids as specified, the bids will be received/ opened on the next working day at the same time & venue.
- 5-Other detailed can be had in the bidding documents. The bid should be duly filled & singed by the tenderer.
- 6-The authority reserves the right to reject any or all the bids without assigning any reason thereof.
- 8- The work should be completed within the stipulated period of 03(three) month of completion and in no case the time extension will be allowed except the reasons not attributable to the Firm.
- 9- In order to ensure that the envelopes are properly sealed, the contractor can seal them with superglue and also add tamperproof tapes as additional precaution. The tender submitted in the wrong box shall not be taken into consideration.
- 10- The quoted rate is inclusive of GST / fitting fro (if required) charges and to hand over the final finished product as applicable by the authority.
