**Contractual engagement of retired Group-C(Ministerial) employees as OSD against the
entry-level Group-C vacant post of Junior Revenue Assistant**

Applications are invited from suitable and willing retired Group-C(Ministerial) employees for their contractual engagement against the 28 numbers of vacant posts of Junior Revenue Assistant on contractual basis for a period of 01(One) year from his/her date of joining or till filling up the vacant posts on regular basis, whichever is earlier, as per erstwhile G.A. Department (Now G.A & P.G Department) Resolution No.23750/GAD, dated 27/08/2014, with monthly consolidated remuneration as per Finance Department O.M No.24533/F, dated 29.09.2022 in pursuance of Revenue & Disaster Management Department letter No.16890 dated 11.05.2023.

Eligibility Conditions:-

- (1) Officers who have retired from Government service on attaining the age of superannuation and below the age of sixty five years having good service records and are physically fit shall be eligible to be considered for re- employment.
- (2) Officers against whom departmental proceedings or criminal cases are contemplated/ pending or who have been penalized for misconduct during the period of preceding five years will not be eligible for consideration.

Monthly Remuneration:-

On engagement, the retired Government servant will avail consolidated remuneration of **Rs.10, 000/- (Ten Thousand)** only per month as per Finance Department Memorandum No.24533/F dated 29.09.2022.

Terms and Conditions:-

- (1) Contractual engaged officers shall be governed by the provisions of Odisha Govt. Servants Conduct Rules, 1957 and shall be liable to be proceeded against for their misconduct, omission and commissions as per the provisions under the Odisha Pension Rules, 1992.
- (2) The contractual engagement can be terminated at any time by the respective appointing authority due to unsatisfactory performance of any of the re-employed officer by giving one month notice. On the contrary if any re-employed officer desires to resign he shall do by giving one month's written notice to the competent authority.




