





1. Sealed tenders are invited from the intending Registered Printing Press/ Supplying agencies having valid GST number for printing and supply of Flex Banner on IEC activities under MAMATA Scheme of Ranpur ICDS Project.
2. The tender paper containing details terms and conditions, EMD statutory requirement etc. can be obtained from the office of CDPO, Ranpur on payment of **Rs.500/- (Rupees Five hundred)** only towards cost of tender paper which is non-refundable.
