The vehicle must be in road worthy condition shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance certificate, fitness certificate, valid contract carriage permit, proof up to date tax payment etc. which are mandatory plying of vehicle.
2. The driver of the vehicle must have a valid driving license for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
3. The driver should well behaved, gentle and obedient in nature.
4. A sum of Rs.5000/- (Rupees Five Thousand) only shall be deposited by intending bidders in shape of Account Payee Bank Draft drawn in favour of the **CDPO, Odagaon** current bearing **A/c No. 912010034356433** and submitted along with the tender as security deposit. 7. The upper ceiling limit for monthly hiring charges excluding POL is fixed at **Rs 15,000/- (Rupees Fifteen Thousand)** only.


