

The Sealed tenders should reach to the undersigned by **Registered Post/Speed Post/By Hand/Courier** on or before **23.02.2024 up to 05.30PM** and it will be opened on **26.02.2024 at 03:00 PM** in Sadbhabana Sabhagruha, Collectorate, Nayagarh in presence of members of Purchase Committee and tenders or their authorized agents. The tender should be submitted in two bids. i.e. **(1) Technical Bid (2) Financial Bid**. The envelope in which the intending bidders will apply should have two separate envelopes for (a) Technical Bid (b) Financial Bid. The above Tender is subject to the Terms and Conditions attached with the Tender Call Notice.

The Tender Papers along with the details of specification of the articles will be available in the Website www.nayagarh.nic.in can be downloaded from the Website. The tender who downloads through website, should pay the application fees of **Rs.500/- (Rupees five hundred) only (Non-refundable)** in shape of Bank Draft/Bankers Cheque drawn in favour of the District Election Officer, Nayagarh payable at Nayagarh from any nationalized bank along with tender document.

EMD of amount as specified in the schedule of requirement in shape of Demand Draft in favour of District Election Officer, Nayagarh, payable at Nayagarh from any nationalized bank, which will be refunded immediately to the unsuccessful bidders after finalization of tender and to the successful tenders after completion of the Task/ Job.
- d. Paper cost on download of Tender from District Website in shape of DD drawn in favour of District Election Officer, Nayagarh, payable at Nayagarh from any nationalized bank. The cost of tender paper is not refundable.
