The Sealed tenders should reach to the undersigned by **Registered Post/Speed Post/By hand/Courier** on or before **06.03.2024 up to 05.30PM** and it will be opened on **07.03.2024 at 03:00 PM** in Sadhabana Sabhagraha, Collectorate, Nayagarh in presence of members of Purchase Committee and tenders or their authorized agents. The tender should be submitted in two bids. i.e. **(1) Technical Bid (2) Financial Bid**. The envelope in which the intending bidders will apply should have two separate envelopes for (a) Technical Bid (b) Financial Bid. The above Tender is subject to the Terms and Conditions attached with the Tender Call Notice.





- c. EMD of amount as specified in the schedule of requirement in shape of Demand Draft in favour of District Election Officer, Nayagarh, payable at Nayagarh from any nationalized bank, which will be refunded immediately to the unsuccessful bidders after finalization of tender and to the successful tenders after completion of the Task/ Job.
- d. Paper cost on download of Tender from District Website in shape of DD drawn in favour of District Election Officer, Nayagarh, payable at Nayagarh from any nationalized bank. The cost of tender paper is not refundable.
- e. Copy of PAN Card.
- f. Copy of the Income Tax return for the last 3 years.
