

Terms and condition of bidding:-

Interested bidders must have to reach at Biswa Agrani WSHG poultry farm, Masabadi, Daspalla on dt. 24.07.2024 before 10:30 AM for registration.


- 1) Items will be presented openly before all the registered bidders only.
- 2) Bidders will bid the price after physically visualizing the items.
- 3) The auction of items will be made lot wise and not for the selected items.
- 4) The items will be sold to the highest bidder on 100% cash payment.
- 5) All bidders should bring their Original Aadhar Cardson the day of auction.
- 6) All bidderswill deposit Rs. 5,000/- (Rupees Five Thousand) only asbid security in cash before start of auction (10.00 AM to 10.30 AM).This deposit shall be adjusted against the auction winning price.Bid security of unsuccessful bidder will be refunded at spot after auction.The refund requestswill not be entertained until completion of auction.
- 7) The highest bidder must have to deposit the amountwithin one hour after being selected and will have to lift the items on the day within two hours of depositing the amount.
- 8) Tax will be withheld as per the Income Tax ordinance .
- 9) After deposition of amount the items will be the property of the depositor& the committee will be no way concern for any mishap/damage/theist occurred thereafter awarding the bid to the highest quoted bidder.
