

**Terms and Conditions for Sanitary Napkin Vending Machine
and Incinerators of Nayagarh district under Samagra Siksha
scheme;**

1. OEM Authorization Certificate:-

Bid specific manufacture Authorization from (MAF) needs to be submitted by the bidder for the Sanitary Vending Machine and automatic indicator for specifically for this bid. Bidder must provide a letter from OEM on their letter head authorizing the supplier to quote and provide services related to supply, installation and after sales maintenance support for the committed warranty period and also provide OEM details such as name, designation, address, email id, contact details etc. are required to be furnished along with the BID.

2. Bidder Type:-

The Bidder should be registered with any Central or Government body/ MSME Registered.

3. OEM Turnover Criteria and Bidder Turnover Criteria:-

1. The bidder should have minimum average turnover of Rs.300.00 lakhs for the last three (03) Financial Year (2020-21,2021-22,2022-23). The Bidder should be profit making entity. Document support:- Balance sheets, Profit and loss account of last three years along with CA certificate with CA's Registration Number and seal along with UDIN. (No provisional or ongoing year documents to be consider).
2. OEM should have minimum average turnover of Rs.500.00 lakhs for the last three (03) years Financial Year (2020-21,2021-22,2022-23). Document support:- Balance sheet, Profit and loss account of last three years along with confirmation certificate of CA in its letter head with registration number and seal. The OEM should attached Financial Creditability Certificate from Bank / Govt. Organization. (No provisional or ongoing year documents can be consider).
3. Tax Returns (ITR) for three assessment year copies of audited balance sheet. Certificate from Chartered Accountant regarding annual turnover of the Bidder and OEM during three financial year. Copy of valid Registration / Incorporation Certificate/ Partnership Deed.

4. Past Performance:-

1. The proposed solution or similar equipment must have supplied through a minimum of 5000 units by OEM/ Bidder during the preceding 02 financial years.(2021-22,2022-23). Document support:- work order from the client with completion certificate or Delivery Challan.
2. OEM must have experience of supply (single work order) of 3000 sanitary napkin vending machine/ Sanitary napkin incinerator machines or single work order value 500.00 lakhs at any Govt. Dept. Document support:- work order from the client and completion certificate or Delivery Challan.
3. Bidder must have experience or minimum 100.00 lakh single work order or more of sanitary vending and sanitary incinerator machine including completion certificate.

5. Additional terms and conditions:-

1. Buyer reserves right to reject any or all bids. All legal disputes are subject to the jurisdiction of Civil Courts at Nayagarh, Odisha.
2. Buyer is liable to reject if essential certificates/ documents as are not made available / uploaded with the Bid documents as per bid document, ATC and corrigendum if any.
3. Bidder shall have to submit complete bid document duly signed and stamped on each documents. Original EMD hard copies must reach to bid inviting authority as started on or before bid closing date and time.
4. Service Centres:- Details of service outlets in state inviting authority to render services for equipment to be furnished to buyer/ consignees with complete address, telephone numbers, emails etc. enclosed with the bid. It shall be the responsibility of seller to ensure that authorized service centres are available.
5. Bidder/ OEM must have Authorized Service Centre within 100 K.M periphery from DPO, Samagra Shikhya, Nayagarh Office, the proof of the same must be submitted along with the BID. (Valid address proof/ Rent agreement should be uploaded). Service Centre within the District will be preferable and service centre Toll Free Number should be given for any query.
6. Bidder should not be blacklisted by any government department, PSU or government company. Black listed agencies are not eligible to bid and bid

is liable for rejection. (Provide declaration on Rs.100 stamp paper not blacklisting along with tender application).

7. The Bidder and OEM must have a valid ISO 9001: 2015, ISO 45001:2018,GMP,CE (Scope Should be Related to the Bid Items),CVC,WAC India, ZED and GEM Expert Gold Certificate.
8. OEM have to submit ISO 14001: 2015, ISO 16732-1:2012, ISO 50001:2018, ISO 15614-5:2004 & NSIC Certificate.
9. In Case of Bidder Trade License and OEM of Factory or Manufacturing License Proof from any govt. Body.
10. Bidder must submit GST Certificate (Odisha GST Preferable) & GST Return of last month.
11. OEM should have production capacity certificate minimum 4000 number of sanitary vending machines and minimum 4000 number of sanitary incinerator machines per month. Document support: NSIC Certificate or DIC production assessment before the date of publish of the tender.
12. Sample of the Product-Bidder shall have an advance sample designed as per contract specifications framework and at least one sample shall be made available on demand w.r.t the date intimated from our end. In case, the sample is found to have deviations/not confirmed to the Contract specifications, the bidder will be rejected.
13. Bidder/OEM shall have to submit NABL test report, Smoke Test report of the sanitary incinerator machine.
14. The bidder and OEM should be in existence for a minimum of 5 years as on the bid submission date supported by Certificates of incorporation, PAN / GST registration certificate.
15. Bidder's financial standing: The bidder should not be under liquidation, court receivership or similar proceedings should not be bankrupt. Bidder to upload undertaking on Rs.20 stamp paper to this effect with bid.
16. Joint Ventures (JV) are not allowed for the supply, installation, commissioning, and warranty maintenance and after sales service. This is the sole responsibility of the OEM/Bidder.
17. Bidder must have to submit a undertaking for Supply, Installation, Testing & Commissioning of the items within 30 days positively after getting supply order. Price includes all expenditure for different school locations. Payment will be made after successful installation of the product at respective location and submission of delivery and Installation report.
18. Bidder must have to submit an undertaking for three (03) year onsite Warranty.
19. Technical Datasheet as per Buyer specifications must be attached while submitting the BID under Bidders Official Letter Head.
20. A proper website has to be provided by the OEM where we can verify all the Certificates, products along with Contact Page for immediate support as per our requirement.



21. A self-declaration certificate must be given for acceptance of all terms & conditions by Buyer while submitting the BID under Bidders Official Letter Head.

Format and Signing of Proposal

The proposal shall be submitted in two parts:

Part A – Technical Proposal

While preparing the Technical Proposal, the bidders/OEMs are expected to examine the documents comprising this tender in detail. Material deficiencies in providing the information requested may result in rejection of a Proposal.

The Technical Proposal shall provide the following information using the attached Standard Forms as enclosed in the Bid document.

- (i) Cover Letter for Technical Proposal (Form A)
- (ii) Bidders Profile (Form B)
- (iii) Similar Project Experience (Form C)
- (iv) Financial Proposal (Form D)
- (v) Undertaking of not listed in Blacklist organization (Form E)
- (vi) Undertaking of not declared as bankrupt under Insolvency and other similar Act- Form-F

Note: The Technical Proposal shall not include any **Financial Information**. The technical proposals shall be spiral/ hard bound.

Part B - Financial Proposal

In preparing the Financial Proposal, the bidders/OEMs are expected to consider the requirements and conditions of the tender document. The Financial Proposal shall follow Standard Form i.e. Bidder/OEM's letter Head.

Note:

- (i) The proposal shall be typed or written indelible ink and shall be signed by the Authorized signatory of the bidder/OEM with seal.
- (ii) Any interlineations, erasures or overwriting shall not be valid only if they are initiated by the person signing the Proposal prior to submission of the Proposal.

- (iii) The rate quoted by the bidder/OEM inclusive of materials, transportation cost, all taxes and any other levies to the consignee point i.e. School Point as per list

Submission of Proposals: Packing, Sealing and Marking of Proposals

The Technical Proposal (Part A) and Financial Proposal (Part B) must be inserted in separate sealed envelopes, along with bidders/OEM name and address in the left-hand corner of the envelope and superscripted in the following manner.

If the outer envelope is not sealed and marked as mentioned above, then DPC, Samagra Shiksha, Nayagarh will assume that the Proposals are being misplaced or opened pre-maturely. The proposals treated as cancelled.

Application Fee

Non-refundable Application fee in the form of Demand Draft from any scheduled commercial bank in favour of "**District Project Coordinator, Samagra Shiksha, Nayagarh**", payable at Nayagarh for **Rs. 10,000/- (Rupees Ten Thousand only)** is to be furnished by the bidder /OEM along with the Technical Proposal. Proposals without the requisite Application Fee shall be treated as non-responsive and rejected outright. No exemption will be entertained.

Bid Security/ EMD:

Bid Security/EMD in the form of Demand Draft from any scheduled Commercial Bank in favour of the "**District Project Coordinator, Samagra Shiksha, Nayagarh**" payable at Nayagarh for **Rs.1,47,000/- (Rupees One Lakhs Fourty seven Thousand only)** for STARs scheme is to be furnished by the bidder/OEM along with the Technical Proposal and shall remain valid till the validity of the Proposal. Proposals without the requisite EMD shall be treated as non-responsive and rejected. No exemption will be entertained.

The Bid Security submitted by unsuccessful bidders shall be returned after issue of the work order with successful bidder/OEM.

Note:

The Bid Security shall be forfeited:

- i. If a Bidder withdraws its Proposal during the period of validity of the proposal,
or
- ii. If the successful Bidder/OEM fails to execute the work assigned as per timeline.

Validity of Proposal

Proposals shall remain valid for 90 days from the last date of submission of proposals. A proposal valid for a shorter period shall be rejected as non-responsive.

Documents accompanying the Proposal

PART A (Technical Proposal)

The bidder must submit the following particulars / documents along with the Technical Proposal failing which the Proposal may be treated as non-responsive.

- a) Non-refundable Application Fee of **Rs.10,000/- (Rupees Ten Thousand)**, in shape of DD from any Nationalised bank drawn in favour of "**District Project Coordinator, Samagra Shiksha, Nayagarh**", payable at Nayagarh.
- b) Bid Security/EMD in the form of Demand Draft from any Nationalised Bank in favour of the "**District Project Coordinator, Samagra Shiksha, Nayagarh**" payable at Nayagarh for **Rs.1,47,000/- (Rupees One Lakh Fourty seven Thousand only) for** STARs scheme Copy of GSTIN (Registered in Odisha)
- c) Cover Letter as per the format in Form-A.
- d) Bidders / OEM profile as per the format in Form-B.
- e) Experience of the Applicant in Form-C (Attach photo copies of similar type work orders along with work completion certificates. In cases, where the work completion certificates for the services are not available, a self-declaration by the bidder on its letter head with contact details of client or an interim certificate issued by the client for an ongoing project certifying the basic eligibility criteria, must be submitted)
- f) The bidder/OEM shall have an average annual turnover of minimum 2 Crores or more (Rupees two Crores) or more for the year 2020-21, 2021-22 & 2022-23. (Audited annual statement shall be attached along with the proposal)
- g) Undertaking of not listed in Blacklist organisation(Form E)
- h) Undertaking of not declared as bankrupt under Insolvency and other similar Act- Form-F

PART B (Financial Proposal)

The Bidder must submit the Financial Proposal as per the format in Form-D with proper signature and seal of the Bidder.

Deadline and mode of submission of Proposals

Proposals filled in all respect must reach District Project Coordinator, Samagra Shiksha, Nayagarh at the address, time and date specified in *table Bidding Schedule of the Bid document* through Speed Post/ Registered Post only **(No in-hand delivery will be accepted)**. If the specified date for the submission of Proposal is declared as a holiday for District Project Coordinator, Samagra Shiksha, Nayagarh, the Proposals will be received up to the appointed time on the next working day.

Late Proposals

Proposals received after the deadline for submission of Proposals prescribed by **District project Coordinator, SS** will be rejected.

Modifications and Withdrawal of Proposals

Proposals received by the office will not be allowed for any modification. Only withdrawal of proposal on the date of opening will be allowed.

Proposal Opening

District Project Coordinator, Samagra Shiksha, Nayagarh will open all the technical Proposals in the presence of Bidders or their authorized representatives along with District Level Purchase and Technical Committee members who choose to attend the proposal opening along-with their sample, at the date and time mentioned and in the location specified by the authority. The representative of Bidders must be authorised originally with due signature, seal of the Bidders letter pad to be submitted on the date of opening otherwise the representative shall not be allowed to be present in opening process.

The Bidders representatives/OEMs present at the event place shall sign a register for their attendance. In the event of the specified date of proposal opening being declared as holiday for District Project Coordinator, Samagra Shiksha, Nayagarh and proposals shall be opened at the appointed time and location on the next working day.

The Financial Proposals of only those firms fulfilling the eligibility criteria and the technical requirements of the proposal shall be opened on the same date.

Performance Security and Agreement
