QUOTATION NOTICE

(SHORT QUOTATIONS CALL NOTICE FOR SUPPLY OF DOUBLE DÉCOR COT. & MATTRESS)

Sealed quotations are invited from the intending register supplying Agencies for supply of 12 no's of Double Décor Cot & Mattress to the District Child Protection Unit, Nayagarh.

The detailed quotations shall be received by the Office of the District Child Protection Officer, Nayagarh on or before 29.07.2024 at 4.00 pm only through registered post/speed post. The same will be opened in presence of the District level purchase committee at 5.00 Pm on 29.07.2024 at the chamber of Collector, Nayagarh (Mini conference hall). The bidders of their representative may remain present at the time of opening of the quotation failing which no complain/dispute in future shall be entertained.

The bidders are to quote unit price of a particular item along with GST, Transportation fees & any other charges as admissible.

The invitation for quotations are subject to the terms and conditions appended below:-

1. The quotations should be sent in sealed cover addressed to District Child Protection Officer, Nayagarh-752069. The wards "Short quotation call notice for **"supply of Double Décor Cot & Mattress"**" should be prominently written on the envelope containing the quotations.
2. The quotation should reach to this office latest by 4.00 PM on Dt.29.07.2024.
3. The quotations will be opened on 29.07.2024 at 5.00 PM.
4. The contact shall be comprehensive and no extra charges will be admissible. The successful bidder is to supply the items to DCPO, Nayagarh within 7 days after placing order.
5. The Order can be terminated by the Purchase Committee, Nayagarh at any time without assigning any reason thereof, if the work of the L1 bidder is found to be unsatisfactory, the Purchase Committee will be a liberty to entrust the same to the next lowest bidder. In this connection, the decision of the Purchase Committee shall be final and binding upon the bidder.
6. Payment will be made on successful completion of the work as per Govt. procedure.
7. Quotation received after due date and time will not be accepted.

8. The Purchase Committee, Nayagarh reserves the right to reject any quotation in whole or in part without assigning any reason thereof.
9. Quotation that does not satisfy the term & conditions are liable to reject summarily.
10. The Quotation should be valid for one year from the date of issuance of supply order.
11. Bidder must furnish full data and information as required.


