The Deputy Director of Fisheries, Puri Zone, Kausalyaganga hereby invites sealed tender from women SHGs of Nayagarh district for taking up lease of Mahisanala reservoir situated in Nayagarh District of Odisha state having MWSA of 45.00 ha for the purpose of fishing activities as per the Odisha State Reservoir Fishery Policy 2012.

Introduction: The Mahisanala Reservoir situated in Nayagarh District of Odisha having MWSA 45.00 ha is available under the water resources Department and having its fishing rights under Fisheries department of Govt. of Odisha.

The bidder/lease holder should submit their tender papers in sealed envelope super scribed as "Tender for Mahisanala Reservoir" covering following aspects.

Terms of reference :

1. Terms and conditions of lease shall be as per the Odisha State Reservoir Fishery Policy 2012 as amended by Govt. of Odisha from time to time. Copy of Reservoir Fishery Policy can be downloaded from the website of Directorate of fisheries, Odisha, Cuttack.
2. The bidder should offer minimum offset lease value of Rs.76500/- for 5 years. It includes lease value, royalty and seed cost.
3. The lease shall be offered for a period of 5 years after approval of tender proceedings by the Director of Fisheries.
4. The bidder/lease holder should visit the proposed reservoir, survey the project area and submit offer for fishing activities.

Tender Paper Cost

- I. The bidder shall furnish Tender Paper Cost of Rs.500.. in the shape of Bank Demand Draft, in favour of Deputy Director of Fisheries, Puri Zone, Kausalyaganga which is non refundable along with quotation.
- II. The bidders can get tender paper from office of District Fisheries Officer, Nayagarh, Office of Deputy Director of Fisheries, Puri Zone, Kausalyagang by submitting demand draft of Rs.500/- in favour of Deputy Director of Fisheries, Puri Zone, Kausalyaganga .
- III. Tender paper can also be downloaded from the website of Directorate of fisheries, Odisha, Cuttack(www.fisheries.odisha.gov.in). In this case the bidder should submit the demand draft of Rs.500/- in favour of Deputy Director of Fisheries, Puri Zone, Kausalyaganga with the Tender paper.

Terms and condition

1. Prevailing financial formalities and regulations as per Govt. rule from time to time will be binding on the bidder.
2. The bidder should offer his bid for the entire reservoir. No bids for the part of the reservoir shall be entertained.
3. The fish sale shall be made in the local market of Nayagarh district and in case of surplus, the bidder can sell the catch outside of the district.
4. The lease holder can not operate mechanized fishing craft for exploitation of fisheries in the reservoir.
5. Each bidder shall submit only one quotation.
6. The SHG must have registered under the Odisha Self Help Co-operative Society act-2001 or SHG recognized by District administration. Essential proof in this regard should be submitted along with quotation.
7. The bidder shall furnish the following documents to establish the bidder's eligibility.
 - a. Financial bid
 - b. Cost of the Tender Paper as specified in the Tender Document.
 - c. Registration / recognition certificate of women SHG.
8. Tender received late and incomplete will not be considered. The bidder should sign and stamp on each page of the Tender document.
9. The undersigned reserves the right to accept or reject any or all the tenders without assigning any reasons thereof.

Last date of submission of sealed tenders

The sealed tenders should be delivered to the address mentioned below on or before 06.08.2024, 5.30PM through Registered post/speed post/ courier service only.

Opening of sealed tenders:

The sealed tenders will be opened 07.08.2024 at 12 noon in the office of Deputy Director of Fisheries, Puri Zone, Kausalyaganga. All the sealed tender will be opened by the tender opening committee along with the bidders or their authorized representatives if any.
