OPEN TENDER INVITATION FOR PROCUREMENT OF VETERINARY MEDICINES, FEED ADDITIVES AND MEDICAL CONSUMABLES

Tenders are invited in sealed cover in two bid systems from wholesaler/Distributors/ C&F Agencies/ Retailer approved by manufacturers dealing with Veterinary Medicines to participate in competitive bidding for supply of the same during the year 2024-25 on the rate contract basis. Bidders have to submit the bids for Veterinary Medicines. They have to submit the Technical bids in one envelope for all categories and price bid//s separately. The technical bid and price bid packed in separate envelope can be submitted to the under signed (**Chief District Veterinary Officer, Nayagarh, near employment office, DRDA Road**) through Registered post/ Speed post / Courier service/ Drop Box in office of CDVO, Nayagarh by 4 PM Dated 01.11.2024. The Tender can be submitted from 10 AM of Dated 26.10.2024. The technical bids of the tender will be opened on Dated 02.11.2024 at 11 am by Tender evaluation committee in presence of the bidder or his authorized representative at the office of the under signed. The date and time for opening of price BID will be informed on the same day i.e. on 02.11.2024 Tender paper can be downloaded and other detail information about this tender is available on this website. Tender processing fee and EMD/BID security money as required by this Tender can be remitted in the shape of demand draft only drawn from any Schedule Commercial Bank, in favour of 'Chief District Veterinary Officer, Nayagarh'. SECTION II

General Definition & Scope Contract

1. General Definitions:

- 1.1 Department means Fisheries & Animal Resources Development Department, Government of Odisha.
- 1.2 Government means Government of Odisha. Bid / Tender Inviting Authority is the CDVO, Nayagarh, who on behalf of the User Institution/Government or the funding agencies calls and finalize bids and ensure supply, procured under this bid document.
- 1.3 Tender Evaluation Committee & Technical Committee are Committees so constituted by CDVO, Nayagarh to decide on the purchase of the drugs/Medicine & consumables to be procured.
- 1.4 User Institutions are the Govt, Animal Health care institution of Nayagarh District under F & ARD Dept., Government of Odisha for which the medicines under this bid are procured.
- 1.5 De-recognition/ Debarment – the event occurring by the operation of the condition under which the bidders will be prevented for a period of 3 years from participating in the future bids of tender Inviting Authority, more specifically mentioned in the Specific Conditions of Contract and General Condition of Contract of this bid document, the period being decided on the basis of number of violations in the bid conditions and the loss/hardship caused to the Tender Inviting Authority on account of such violations. Withdrawal or non-compliance of bid terms and condition after the issuance of supply Order will lead to de-recognition/ debarment of the successful bidder.

2 Scope

- 2.1 The bids are invited for the supply of the items, the details of which are mentioned in Annexure I and Annexure-II, needed for the Govt. Animal Health care institutions of Nayagarh dist.

- 2.2 The bidders can't withdraw their bid after opening of technical bid, within the minimum bid validity period of 180 days & also after accepting the Letter of indent.
- 2.3 Withdrawal or non-compliance of agreed terms and conditions after the execution of agreement will lead to invoking of penal provisions and may also lead to de-recognition/debarment.

SECTION III

General instruction to bidders

This tender is floated in 2 Bid systems for Veterinary Medicines

- EMD/Bid security deposit has been exempted vide Finance Department Office Memorandum No. 8484/F Dated 05.04.2022 up to 31st December 2022. Instead the bidder has to submit "Bid Security Declaration" in prescribed format.
- At any point of time, the Tender Inviting Authority reserves the right to reject the tender for all items or for any one or more of the items tendered without assigning any reasons thereof.

SECTION IV

GENERAL TERMS AND CONDITION

1. **The Chief District Veterinary Officer, Nayagarh, Odisha** (Tender Inviting Authority) working under Fisheries & Animal Resources development Department, Govt. Of Odisha for providing Animal health care services, requires various Veterinary Medicines to be used by various Subordinate health care institutions (hereinafter referred to as user institutions).
2. Sealed tenders will be received by **Dated.01.11.2024 up to 4 PM** by the Authorized officer at office of the Chief District Veterinary Officer, Nayagarh through Courier/Speed Post/ Regd. Post only (not by hand) for the purchase and participation in the open tender for supply of "Veterinary Drugs, Feed additives and Medical Consumables" for a period of one year. The bidder can tender the Bid documents **by dropping in the "Drop Box"** kept at office of the CDVO, Nayagarh by dated 01.11.2024 up to 4 PM. Any tender received after the due date & time will be rejected / returned to the sender unopened.
3. The bidder(s) shall have to submit their tender in separate sealed envelopes, i.e. one for technical bid by super scribing Cover "A" (Technical Bid) & Cover "B" (Price Bids). The Technical Bid and Price Bids should be put into a third Cover, which should be super scribed as **"Tender for Veterinary Medicines"**. On this cover the address of sender and Receiver need to be clearly mentioned.

4. The Sealed tenders "Cover A" (Technical Bid) submitted by the bidders will be opened at the Office of the CDVO, Nayagarh by the Tender Evaluation Committee in presence of Bidders or their authorized representative. In situation of absence of participation of Bidder/ authorized representative during the process of opening of Technical bid cannot be stopped. The bidder will have no right to claim any sort of imposition to make the process null and void. But due to any unexpected untoward situation, if the process of opening of technical bid has to be stopped, the notice for next date of opening the technical bid will be displayed in the office notice board and also it will appear in the official website of NIC, Nayagarh. The Technical Bids will be opened on Dated.02.11.2024 at 11 AM.
5. No tender documents shall be accepted after the expiry of scheduled date and time.
6. The details of items and specification which one can appreciate to submit bid are mentioned at Annexure-I.
7. Rate should be quoted in Indian Currency (with paisa in two decimals only), both in word and figures against each item as the payments will be made in Indian currencies only. The tender shall not quote the rate for any item other than the item specified in the list. The GST shall be charged as per the guidelines given by the Finance Dept. Govt. Of Odisha/India from time to time. TDS of 2% of GST will be made as per rule.
8. The interested bidder can download the Entire Tender Document from the website <http://nayagarh.odisha.gov.in> He can have the tender documents from office the CDVO, Nayagarh from account section by making a Govt. Deposit of Rs. 1000/- (Rs. One Thousand Only) towards the tender processing fee.
9. All the sheets of technical Bid along with bid document shall be serially numbered and duly attested by the bidder. Any deviation will liable for rejection of bid.

10. Tender processing fee and EMD

The firms desirous to participate in the bid process shall have to submit Tender Processing fee in shape of demand draft of Rs. 1000/- (Rs. One Thousand Only) drawn at any Nationalized bank in favour of "Chief District Veterinary Officer, Nayagarh". The demand draft of Govt. Money receipts of Rs. 1000/- is to be attached with the Technical bid documents.

11. ELIGIBILITY CRITERIA

Veterinary drug Distributors / Wholesalers/ C & F Agents/ Veterinary drug Manufacturers authorized supplier for Veterinary medicines and Firms dealing with medical Consumables/ Retailers are eligible to participate in the tender provided, they have;

- (i) Valid Wholesale/ Distributor Drug License/ Trade License from the Drug Controller (O)/ competent authority.
- (ii) Firm should be authorized by Manufacturer for sale/ distribution of particular products/items incorporated in this tender.

- (iii) Bidder shall have the capacity to supply at least 50% of the ordered items within 7 days and rest of the items within 15 days of placement of supply order. Failure of supply within stipulated period may result in cancellation of order followed by forfeiture of performance security deposit.
- (iv) Bidders need to have experience for one year in supplying Veterinary Medicines to State Govt./Central Govt./State or central Govt. PSUs. In support of experience the bidder has to submit experience certificate or copy of the bills of the product supplied along with documents submitted for technical bid.
- (v) Annual turnover
The bidder should have annual average turnover of Rs.10 Lakh per year for the last three years i.e. during 2021-22, 2022-23 & 2023-24. Bidder shall have to produce turn over certificate from Chartered accountant.
- (vi) Shall have Pan Card & valid GST registration.
- (vii) Valid/up-to-date Tax (I.T & GST) return certificate. GST should be cleared up to financial year 2023-24. (31st March 2024).
- (viii) Bidders who have been blacklisted either by the Tender inviting authority or by any State Govt. or Central organisation OR PSU is not eligible to participate in the tender for that item.
- (ix) The supplied medicines should have minimum 1(one) year expiry from the date of receiving the medicine by the Tender inviting authority.

12. COVER-B (PRICE BID)

- (i) The price bid format giving the quoted rate for Veterinary medicines should be sent in a separate sealed covers here after called **Cover "B" (Price Bids)**.
- (ii) The price of the item should be quoted inclusive of insurance, Packing, forwarding, freight (door delivery) and inclusive of GST if any. The rate should be quoted for each item both in figures and words.
Only two decimal points (paise) will be taken into consideration ignoring the rest digits. In case of difference in words and figures, words will be taken into consideration for evaluation.
- (iii) The quoted rates should be final and shall not be subject to any escalation during the validity of rate contract. The bidder should submit/furnish a certificate in the tender to the effect that the price quoted by them is not more than the open market price. However, in circumstances when the price decreases during the contract period, the approved supplier should ethically intimate the same to the purchasing authority and decreases the price accordingly.

13. The cover "B" of the bidder whose tender qualified technically in cover-A will only be opened.

Rejection of the Tender:

The tender paper (whole/part) will be rejected, if any of the following documents are wanting/not found with the tender bid:

- (i) Non submission of relevant documents as motioned in Section VI.
- (ii) Sealed price bid (quoted rate) without signature and seal.
- (iii) Any pre-condition by the bidder contradicting to the tender terms & conditions or non-compliance to product specification.

14. Evaluation:

- (i) Tenders will be evaluated as per the requirement of the bid and the price bid (Cover-B) shall be opened only for those bidders who will qualify in the technical & sample evaluation.
- (ii) The cost of the unit item including Taxes/GST will be evaluated.
- (iii) If the approved lowest eligible supplier fails to supply items within the stipulated period of rate contract, to meet the need, the tender inviting authority reserves right to procure the same from the L2/L3 suppliers at L1 rate, if they agree to supply at L1 approved rate or negotiated rate.

15. Performance Security:

The bidder shall have to submit performance security @ 3% of the supply order value of approved items within 7 days of issue of letter of intent (LOI) in form of Demand Draft Drawn in favour of Chief District Veterinary Officer, Nayagarh payable at Nayagarh/Irrevocable Bank Guarantee from any Nationalised/ Scheduled Bank in favour of the Chief District Veterinary Officer, Nayagarh in the format as given in Document with validity for a period of **24 months** from the date of execution of it.

16. Notification of award/Letter of Intent (LOI):

- (i) Within the bid validity period, the Tender Inviting Authority will notify the list of successful bidder(s) in tender before issuing the Letter of Intent (LOI).
- (ii) The successful bidder(s), upon receipt of the LOI, shall deposit the prescribed performance security within 10 (ten) days.

Delivery:

Supply shall be completed within 15 days from the date of issue of purchase order or as mentioned in the purchase order. Delivery shall be made at Central-store of CDVO, Nayagarh.

17. Payment:

100% payment shall be made after submission of stock entry certificate(s) from the concerned authority and as per the availability of funds. Under no circumstances the supply should be interrupted as regards to payments.

18. Penalties:

If any product after use found to be "Not of Satisfactory Quality"/ Not as per the parameter/ gives adverse reaction upon consumption", such item will be declared as "Not of Satisfactory Quality" on the basis of the report of the concerned user institutions. The said product shall be frozen. The supplier has to replace fresh stock equal to the purchased quantity and take back the frozen stock at his own cost. In case the supplier fails to replace the stocks, the Performance Security shall be forfeited.

19. Miscellaneous Conditions:

- (i) The tender documents should be clearly written / typed without any correction, interpolations, and overwriting. Each page of the tender should be page numbered with the dated signature of the bidder. If any information or documents furnished by the bidder found to be misleading/incorrect at any stage, their tender will be rejected.
- (ii) The approved rate and supplier will be valid for one year from the date of approval. In case of any unavoidable situation, the tender inviting authority may extend the rate contract till finalization of new rate contract for greater interest of public at large.

All legal disputes, if any relating to purchase etc, are subject to jurisdiction in the courts of law situated at Nayagarh, Odisha or Orissa High Court.


SCHEDULE OF REQUIREMENT

3. The Approx. Quantity mentioned may substantially vary from order quantity.
4. The medicinal items should have sufficient gap between date of supply and date of expiry (Not less than 1 Year).
5. Damaged items will not be received under any circumstances.
6. Supply of drugs without the prescribed labelling will not be accepted.
