

SHORT TENDER /QUOTATION CALL NOTICE

The Sub-Collector, Nayagarh-cum-Chairman, R.M.C., Bahadajhola invites item wise rate quoted bid in sealed cover from the reputed manufacturer or their authorized registered dealers for supply, installation and commissioning of following Grading Equipments for paddy procurement operation KMS 2024-25 under RMC Bahadajhola as per specifications mentioned in letter No 1720 Dtd: 20.08.2019 of OSAM Board.

The bidder shall have to submit double cover system (Cover-I: TECHNICAL BID & Cover-II; PRICE BID) and super-scribe the covers separately. The detail bid documents shall be available from Dt. **23.11.2024 to 03.12.2024 up to 5.00 pm** in the District website i.e. <http://nayagarh.odisha.gov.in>

NAME OF THE REQUIRED GRADING EQUIPMENT

1. Electronics Weighing Scale (300Kg)
2. Digital Moisture meter (with printer) of latest version with compatible Bluetooth and USB connection.
3. Analysis Kit
4. Set of Sieves.
5. Sample Divider
6. Mini Seed Grader/Mini Grader
7. Plastic Water Filter (Milton 25-30 liter.)
8. Temporary Rest shed (Bamboo tent ,size 10x15 ft)

TERMS & CONDITIONS:

1. The Offer should be of two parts Viz., “**TECHNICAL BID**” and “**FINANCIAL BID**”.
2. The Mentioned Equipments will be International Organization for Standardization (ISO) standard or BIS standard.
3. Manufacture / Their authorized Dealer / Reputed firm are eligible to quote in this tender. Authorized dealer should attach letter of authority from principal Manufacturer to quote in this tender.
4. Bidders should have at least 3 year work experience of supply of similar products to any five nos. government organisations or RMCs and should have also experience of supply of each articles prescribed tender to any government organisations or RMCs in odisha. Copy of supply orders to be submitted in technical bid for proof of experience.
5. Bidder submitted without technical specification and compliance statement, that bid will be summarily rejected.
6. **Completion of Work:** The mentioned above items except Sl. No. 6 must be delivered within 7 days from the issuance of Purchase Order / Contract.
7. Bidder should submit the GST, PAN and ISO/BIS certificate of Manufacturer, if the bidder is Authorized Dealer.

8. Bidder must submit a notarized latest affidavit in non-judicial stamp paper of value Rs. 100.00 after the date of publication of bid that their firm has not been blacklisted by any PSU/ central or state govt. department.
9. **Declaration:** Declaration should be submitted for Products quoted in the bid are not obsolete in the market and has at least 5 years Residual Market Life-Supporting Declaration required from the OEM letter head.

10 Undertaking: The bidder should not be under liquidation, court receivership or similar proceedings should not be bankrupt. Bidder to upload undertaking to this effect with bid.

10. Bidder should have own service centre in odisha to extend service support as and when required on priority basis and necessary documents to be submitted for its proof.

11. **Tender Processing Fees:** Bidder should submit DD of any nationalized bank of Rs. 2000.00 in favour of Regulated Market committee, Bahadajhola and payable at Nayagarh against **tender processing fees / tender cost** (Non-Refundable) and the original DD should reach with tender documents to Office of the **Secretary, RMC, Bahadajhola, At- Multi-commodity Market yard campus, Plot no.178, Hatapada, Khandapada Road, Nayagarh, Pin-752069** before the closing date of the bid through speed / reg. post. Paper cost is mandatory for all bidders.

12. **Earnest Money Deposit (EMD):** Bidders should submit EMD amounting Rs.100000/- for Weighing Scale and Rs 20000 for each other articles in shape of DD of any nationalized Bank in favour of Regulated Market Committee, Bahadajhola and payable at Bahadajhola and the original DD towards EMD should be attached in bid documents. The EMD will be returned to all bidders within a reasonable time. The EMD deposited by successful bidder will be retained as the security deposit. Retained Money shall be refunded after one year from date of successful completion of work or after completion of paddy procurement 2024-25,if performance of equipments satisfactory . EMD is mandatory for all bidders. No EMD is required for installation of temporary tent shed.

13. The Purchaser reserve the right to forfeit the EMD if the successful bidder fails to supply the required items in prescribed time with terms and condition. If any bidder gives false documents in this tender process for qualifying and came to know at later stage than the concerned firm will be blacklisted and deposited EMD will be forfeited.

14. The EMD and security Deposit shall carry no interest.

15. In Case of any damage of supplied material during transportation, loading and unloading, that will be replaced by the bidder free of cost.

16. **Warranty Terms:** This warranty / guarantee shall remain valid for a minimum **24 months** from the date of supply and installation. The Purchaser shall promptly notify the Supplier, in writing, of any claims arising under this warranty. Upon receipt of such notice, the Supplier shall, with all reasonable speed, repair or replace the defective Goods or parts thereof, without cost to the Purchaser.

17. The Rates should be quoted separately for each item by bidders and quoted Rate should be inclusive of all taxes.

18. All Price quoted by the bidder shall be valid for a period of one year from the date of acceptance of the lowest bid.

19. The Rate offered by the bidder will be inclusive of all taxes, cost of transportation till destination and installation and commissioning.




20. Supplier shall produce their product as per attach specification for technical verification And demonstration before purchase committee during opening day of technical bid i.e. dt.- **04.12.2024.**
21. **Payment** : No advance payment towards equipments to be made to bidder and 80% of bill amount is to be released on receipt of Tax invoice and Balance 20% bill amount will be released to Supplying Firm after completion of Paddy procurement operation 2024-25.
20. If the successful **L1** bidder fails to supply the required items within prescribed time period then **L2** bidder may be invited to supply the same as per quoted price of L1 bidder with same terms and condition, if agree.
21. Late & delayed quotation offers will not be considered at all.
21. The Tender will be opened on dated **04.12.2024 at 12.30 PM** in office of the Regulated Market Bahadajhola, Nayagarh in presence of the bidder or their authorized representative and Members of Purchase Committee.


