
NOTICE

Applications are invited from eligible candidates for filling up 05 nos of Launch drivers on temporary basis with monthly consolidated remuneration of Rs.13,900/- per person and 04 (four) nos of Khalasi on Temporary basis with monthly consolidated remuneration of Rs. 12,600/- per person from the date of engagement to **30.11.2025** in Nayagarh district for manning the boats of the State Port Engineering Organisation under the control of Special Relief Commissioner, Odisha. The application along with relevant documents and self-attested copies Certificates and other particulars must reach in the office of the **Collector & District Magistrate, Nayagarh Odisha-752069** by **5 P.M** on or **19/06/2025** either in person during office hours on each working day or through Register Post/ Courier Service. Applications received in the office **after the due date & time** shall be **rejected**.

CONDITIONS:-

1. The incumbents engaged to such posts above are not eligible to get any TA, DA, Conveyance or any other allowance.
2. The engagements are to be made in a phased manner depending on the actual requirement. Copy of the engagement order(s) along with their mobile No. shall be sent to SRC, Office.
3. Engagement of Temporary boat crew shall be given to the operational boats only @ one Launch Driver and One Khalasi per boat considering the regular boat crew (if any) available for that boat.
4. Candidates applying for the post of Temporary Launch Driver must possess minimum 2nd class Launch Driving Certificate issued by proper authority.
5. The applications received till 19.06.2025,(5.00 PM) shall be scrutinized by the District Administration on dt.20.06.2025 for the both post.
6. Technical test of the candidates for the post of Launch Driver will be taken by the district administration with the help of State Port Engineer /AEE (Mechanical) / Junior Engineer (Mechanical) of SPEO. Candidates who qualify in such test along with other requisites including good behavior & conduct shall only be engaged.
7. The Candidates for both the posts will have to pass swimming test in river, canal or any running water body for a distance of 200 mtrs. In 20 minutes. Assistance of Local Fire Officer/ Assistance Fire Officer must be taken to ensure safety measures during such tests.

8. Fresh candidates (without any prior work experience) applying for the post of Boat Khalasi on temporary basis must possess crew Training completion certificate from Crew Training Institute and fresh candidates applying for the post of Launch driver must possess 2nd class Launch driving certificate from Director of ports & Inland Water Transport, Odisha.
9. Candidates having prior work experience with SPEO in the same post as applied for shall be given preference over others.
10. Selected candidates shall be required to submit a certificate of fitness from a Govt. medical practitioner before joining.
11. The place of posting of successful candidates should be carried out after consultation with SEPO for better service and care of the power boats especially for the boats which remain in water body throughout the year.
12. The engagement will be valid **from the date of joining of the person till 30.11.2025.**


