


TENDER CALL NOTICE

SUPPLY OF DIETARY AND MISCELLANEOUS ARTICLES TO SUB-JAIL, RANPUR IN THE DISTRICT OF NAYAGARH FOR THE YEAR 2026-27.

Application in plain paper are invited from the intending supplies/firms/co-operative societies/contractors/corporations/MSME & Start-Ups firms who are registered dealers under GST ACT for registration of their names as approved suppliers for supply of "Principal Food grains" and other "Misc. Articles" including vegetables, Chicken, Milk Eggs, Pannier etc. As per approved schedule of articles to Sub-Jail, Ranpur of odisha during the year 2026-27 to be received by the superintend of concerned Jails relating to his institutions only up to 5:00 P.M of 29.12.2025. The broad guidelines for submission of application are as follows.

1. The applications should state in their applications, their financial capacity and past experience, if any, for consideration of their cases for registration as approved supplier.
2. The application should submit the IT Return having Gross Annual income of Rs. 8.00 Lakh and above for Circle Jails, Rs. 6.00Lakh and above for District Jails & Special Jails and **Rs. 4.00 Lakh and above for Special Sub-Jails and Sub-Jails for last three financial years (2022-23, 2023-24 and 2024-25)** duly filed before the Competent Tax Authority.
3. The application having required income Tax Returns should be allowed to supply materials to a Sub-Jail, Ranpur as the case may be. The photo copies of the documents dully self-attested by the bidder in support of their Income Tax Returns and past experiences if any together with a copy of PAN card and GST Returns up to 30.09.2025 in sealed cover should be submitted, along with their applications for registration of their names in the Jail Office as approved supplier.
4. The Bidder should have a **valid Food Registration / Food License under Food Safety and Standard Act.2006.**
5. Acknowledgement of application along with all the documents and the date & time of verification of such documents should be obtained from Superintendent Sub-Jail, Ranpur.
6. On the date of registration, the original certificate of the above documents should be produced before the Superintendent for registering their names as approved supplier.
7. No application for registration will be entertained by the superintendent of Sub-Jail, Ranpur, if it is not received within the stipulated time.
8. The registered supplier will be eligible to submit the tender for that Jail only.
9. Paper submitted by the intended suppliers to participate in the tender process should be attended by the Superintendent Sub-Jail, Ranpur immediately and intimation to verify the original documents of the supplier may be given with sufficient reasonable time for verification by the Superintendent Sub-Jail, Ranpur on the due date.
10. If any intended supplier requests for extension of time for verification of original documents due to clash of verification date with other Jails, their prayer may be considered and they may be allowed reasonable time to attend for verification of original documents in time.
11. The bid security(also known as earnest money deposit(EMD)) is to be obtained from the bidder along with sealed tender paper. The exact amount bid security should be between 2% to 5% of the estimated value of the articles tendered or as per OGFR guidelines issued by the Superintendent Sub-Jail, Ranpur.
12. The bid security may be obtained in the form of account payee demand draft, fixed deposite receipt, Banker's Cheque. Bank Guarantee from any of the commercial banks in an acceptable form.
13. The Local MSE registered while participating in tenders shall be allowed for concessional payment of EMD as per guidelines issued by Government from time to time.




14. The Superintendent shall take necessary steps for forfeiture of EMD in case of the successful bidder fails to sign the Agreement within 15 days from the issue of Letter of Intent or the successful bidder fails to provide the performance Bank Guarantee as required at the time of signing of the Agreement or if a bidder withdraws its bid during the period of bid validity.
15. EMD of all bidders would be refunded by Superintendent after submission of Performance Bank Guarantee by Successful bidder.
16. Prior to submission of Tender, the suppliers are required to obtain all other information concerning to the terms and conditions of contract and details of probable requirement of articles from the Superintendent of Jails concerned. As the Jail population fluctuates from time to time, exact requirement can not be indicated specifically at the time of submission of tender.
17. The approximate quantity of supplies of principal food grains and other Misc. Articles for the year 2026-27 in respect of Jails of the State are titled as "Approved schedule of articles" and available with the Superintendent of Sub-Jail, Ranpur. The articles are required to be delivered at the respective jail gates.
21. The competent authority i.e.- D.G of Prisons & D.C.S, Orissa reserves the right, in the public interest, to reject any tender without assigning any reasons thereof and may order the concern superintendent to purchase articles from the open Market, if rates, terms and conditions of the tender are not agreeable.
22. After registration with the superintendent of Sub-Jail, sealed tenders quoting rates etc. to be submitted directly to the Superintendent Sub-Jail, Ranpur on or before **5.00 pm of 03.02.2026** sealed tenders will be opened at **3.00 pm on 04.02.2026** or in consultation with the chairman of the purchase committee.


