



The Executive Officer on behalf of **Office of the NAC, Khandapada** invites Percentage Rate Bids in conformity with detailed Tender Call Notice (DTCN) for 17 (Seventeen) nos. of Civil Works from Registered Contractors of Govt. of Odisha as mentioned below. The Tender documents for the works will be available from the office of the undersigned during office hour from **dt.20/02/2026 to dt.27.02.2026** excluding Govt. holidays on payment of Tender Paper Cost in shape of Money Receipt or Demand Draft/ Bankers cheque issued from any Nationalised Bank in favour Executive Officer, NAC, Khandapada payable at Khandapada. The bidders must submit EMD in shape of Money Receipt or TDR issued from any nationalized bank in favour of Executive Officer, NAC, Khandapada payable at Khandapada failing which the bid will be rejected. The Contractor should have experience in execution of similar nature works. They should furnish photo copies of (i). Valid Contractor license, (ii). PAN, (iii). GST Clearance, (iv). Affidavit about the authentication of tender documents along with tender documents. The last date of Form selling is **dt.27.02.2026** up to **5.00 PM** and submission of tender paper in Tender box/ Registered post, on **dt.02.03.2026** up to **1.00 PM** and will be opened on the same day at **3.00 P.M** by the tender committee in presence of the Tenderers or their authorized representatives. All other relevant information can be had from the office of the undersigned. The authority reserves the right to reject any or all tenders without assigning any reason thereof.

TERMS & CONDITIONS FOR

TENDER CALL NOTICE NO. 360 DATE 17/02/2026

1. The Executive Officer, NAC, Khandapada invites sealed tenders in conformity with detailed tender call notice to be eventually drawn in contract form F2 for 17(Seventeen) Nos. of civil works from eligible registered contractors of this NAC & all the state Govt. registered contractors who have D & C Class License.
2. Bid documents containing plans, specifications, the schedule of quantities & terms & conditions of contract and other necessary documents can be availed from the office of the NAC, Khandapada during office hours every day except on Sundays and Public Holidays till last date of sale and receipt of tender papers.
3. Tender must be accompanied with the scan copy of E.M.D in shape of Money Receipt or TDR issued from any nationalized bank for an amount as specified for each work in the table above & Cost of Tender Paper, in shape of Money Receipt / Demand Draft/ Bankers Cheque issued from any nationalized bank payable at Khandapada and drawn in favour of Executive Officer, NAC, Khandapada . The E.M.D and paper cost are to be submitted in original with tender document .
4. The sale of documents will start from **Dt.20.02.2026** and close on **27.02.2026** at **5.00 PM** during working days.
5. The Bids must be delivered in the Tender box kept in the office room of this NAC, Khandapada within **dt.02.03.2026** up to **1.00 PM**.
6. The Bid documents, requested by mail will be dispatched by registered post / speed post on payment of an extra amount of Rs.100.00 (One Hundred) only over the cost of tendered documents. The Executive Officer will not be responsible for the postal delay if any in the delivery of the documents.
7. The bid will be opened on **dt.02.03.2026** at **3.00 P.M** in the NAC Office in presence of the bidders or their authorized persons who wish to attend. If the office happens to be closed on the last date of receipt of the bids as specified, the last date of receipt will be extended by the days of closure of office and will be opened on the next office day at the same time and venue.
8. The bidders are required to furnish the photo copy of Valid Registration Certificate, GST/VAT Clearance Certificate and PAN Cards along with the Bid documents, otherwise the bid shall be declared as non responsive and thus liable for rejection.
9. Cash receipt against purchase of tender paper will be issued without mentioning the name of the contractor but with mentioning the name of the work for which purchase has been made.
10. The tenders are required to execute the work as approved specification.
11. Other details can be seen from the bidding documents.
12. The bidders will make at his own cost at the site for the proper storage of the materials.
13. The bidders will engage labourer as per the direction of the Govt. from time to time & will arrange medical Aid & other Aid facilities to them at his own cost.
14. The bidder will execute one agreement with the undersigned as per the terms & conditions of NAC, Khandapada before starting the work and no extension of time will be allowed for completion of work without any sufficient reason as per his request.

15. No. compensation will be paid to the executants or his associate for any loss of human life or others during Natural Calamity or any other mishap.
16. NO excess rate quoted by the bidders over the estimated cost of the work will be allowed.
17. Any other terms & conditions as per the O.P.W.D. Code & instructions / directions issued by the state Govt. from time to time will be strictly followed.
18. Payment will be made subject to availability of funds.
19. If, more than one bid is quoted (decimal up to two numbers will be taken for all practical purposes) either at the estimated cost put to tender or less than the estimated cost put to tender the tender accepting Authority will finalize the tender through a transparent lottery system, where all the concerned bidders/ their authorized representatives the concerned SE/EE of the concerned Division and Divisional Accounts Officer (DAO) will remain present.
20. If the rate quoted by the SC and ST Category Contractors comes to the rate quoted by the L1 bidder (decimal up to two numbers will be taken for all practical purposes) after availing 10% price preferences as per Para 2 of Works Department Resolution No.27748 dated 11.10.1977 the tender shall be finalized by the tender accepting authority through a transparent lottery system along with other categories of contractors.
21. **Additional Performance Security (APS)** shall be taken on an incremental basis from the selected bidder for low bid prices in the project works as per **OM No.0776460022025 173/W, Bhubaneswar Dt.03.01.2026** of Works Department as follows and tender will be finalized as per **O.M. No.0776460022025 632/W Bhubaneswar Dt.09.01.2026** of Works Department.
 - I. **where the bid price is below 0% but not below 10% of the project cost put to bid,** no additional performance guarantee/ security percentage is required.
 - II. **where the bid price is below 10% but not below 20% of the project cost put to bid,** the additional performance guarantee/ security percentage shall be incremented by 0.1% for every percentage of bid price below 10% of the project cost put to bid starting at 11% with the additional bid performance guarantee being 0.1% and this additional performance guarantee percentage shall be applied on the bid price;
 - III. **where the bid price is 20% or more below of the project cost put to bid,** the additional performance guarantee percentage shall be incremented by 0.2% for every percentage of bid price below 20% of the project cost put to bid in addition to 1% of the bid price and this additional performance guarantee percentage shall be applied on the bid price;
 - IV. The additional performance guarantee percentage shall be rounded off to the next lower percentage based on whether the decimal point of the percentage of bid price is below 0.5% or next higher percentage based on whether the decimal point of the percentage of bid price is 0.5% or more.
 - V. The additional performance security shall be treated as part of the performance security.
 - VI. Justification for abnormally low bids shall be scrutinized by the Departmental Technical Committee and recommended to the competent authority of the Administrative Department for the approval of the Additional Performance Security (APS). An abnormally low bid is one in which the Bid price in combination with other elements of the Bid, appears so low that it raises material concerns as to the capability of the Bidder to perform the contract at the offered price. Procuring Entity may, in such cases, seek written clarifications from the Bidder, including detailed price analyses of its Bid price in relation to scope, schedule, resource mobilization, allocation of risks and responsibilities and any other requirements of the bid document. If after evaluating the price analyses, the procuring entity determines that the Bidder has substantially failed to demonstrate its capability to deliver the contract at the offered price, the Procuring Entity may reject the bid/ Proposal. However, it would not be advisable to fix a normative percentage below the estimated cost, which would automatically be considered as an abnormally low bid.

22. The authority reserves the right to reject any or all the tenders without assigning any reason thereof.
23. The Bidder will provide his E-Mail ID and Mobile No. for smooth communication positively. Failing which , they will not be intimated in writing letter in all future and they have no right to ask any question to us in all future.
