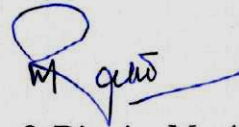

The quotation shall opened on 18.05.2026 at 11.30A.M by the Collector, in presence of the Tender Committee and their representatives may remain present at the time of opening of the quotation failing which no complain/dispute in future shall be entertained.

The bidders are to quote unit price of a particular item along with GST, Transportation Fees & any other charges as admissible.

The invitation for quotations is subject to the terms and conditions appended below:-

1. The quotations should be sent in Sealed Cover addressed to District Social Welfare Officer, Nayagarh, At/po/Dist-Nayagarh-752069. The words "Short quotation call notice for supply of Training materials (Bag/Folder, Writing Pad & Pen) under Poshan Bhi Padhai Bhi Initiative" should be prominently written on the envelope containing the quotations.
2. The quotation should reach to this Office latest by 10.30 A.M. on dated 18.05.2026.
3. The quotations will be opened on 18.05.2026 at 11.30 A.M.
4. The contact shall be comprehensive and no extra charges will be admissible. The successful bidder is to supply the items of ICDS Project of Nayagarh District within 10 days after placing order.

5. The order can be terminated by the Collector, Nayagarh at any time without assigning any reason thereof. If the work of the L1 bidder is found to be unsatisfactory, the Collector, Nayagarh will be a liberty to entrust the same to the next lowest bidder. In this connection, the decision of the Collector, Nayagarh shall be final and binding upon the bidder.
